

ORDINANCE NO. 13,957

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, and amended by Ordinance 13,835, passed August 28, 2001 by repealing Sections 114-2820, 114-2832, 114-2833, 114-2843, 114-2846, 114-2852, 114-3225, 114-3401, and 114-3464 thereof and enacting new Sections 114-2820, 114-2832, 114-2833, 114-2843, 114-2846, 114-2852, 114-3225, 114-3401, and 114-3464, and adding and enacting new Sections 114-2944.01, 114-2946.01, 114-3033.01, 114-3033.05, 114-3033.09, 114-3486.01, 114-3581.01, 114-3708.01 and 114-3708.05 relating to traffic and vehicles.

Be It Ordained by the City Council of the  
City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, is hereby amended by repealing Sections 114-2820, 114-2832, 114-2833, 114-2843, 114-2846, 114-2852, 114-3225, 114-3401, and 114-3464 thereof and enacting new Sections 114-2820, 114-2832, 114-2833, 114-2843, 114-2846, 114-2852, 114-3225, 114-3401, and 114-3464, and adding and enacting new Sections 114-2944.01, 114-2946.01, 114-3033.01, 114-3033.05, 114-3033.09, 114-3486.01, 114-3581.01, 114-3708.01 and 114-3708.05 relating to traffic and vehicles, as follows:

**Sec. 114-2820. Southeast Twenty-fourth  
Court--Dean Avenue to East Leach Avenue.**

Southeast Twenty-fourth Court, on both sides, from East Market Street to a point 300 feet north thereof, no parking any time.

Southeast Twenty-fourth Court, on both sides, from Railroad Court to East Railroad Avenue, no parking any time.

Southeast Twenty-fourth Court, on the west side, from East Leach Avenue to East Twenty-fifth Street, no parking any time.

**Sec. 114-2832. Southeast Twenty-fifth Street--East Court Avenue to East Leach Avenue.**

Southeast Twenty-fifth Street, on the east side, from Shaw Street to Maury Street, no parking any time.

Southeast Twenty-fifth Street, on both sides, from Railroad Court to East Railroad Avenue, no parking any time.

Southeast Twenty-fifth Street, on the east side, from Southeast Twenty-fourth Court to East Leach Avenue, no parking any time.

**Sec. 114-2833. Southeast Twenty-sixth Court--East Court Avenue to East Leach Avenue.**

Southeast Twenty-sixth Court, on the west side, from Scott Avenue to C.B. & Q. Street, no parking any time.

Southeast Twenty-sixth Court, on the east, from East Leach Avenue north to and including the cul-de-sac, no parking any time.

**Sec. 114-2843. Southeast Twenty-seventh Court--East Market Street to East Leach Avenue.**

Southeast Twenty-seventh Court, on the west side, from East Market Street to C.B. & Q. Street, no parking any time.

Southeast Twenty-seventh Court, on the east, from East Leach Avenue north to and including the cul-de-sac, no parking any time.

**Sec. 114-2846. Southeast Twenty-seventh Street--East Market Street to East Leach Avenue.**

Southeast Twenty-seventh Street, on the west side, from East Market Street to Scott Avenue, no parking any time.

Southeast Twenty-seventh Street, on the west side, from a point 600 feet north of Maury Street to East Railroad Avenue, no parking any time.

Southeast Twenty-seventh Street, on the east, from East Leach Avenue north to and including the cul-de-sac, no parking any time.

**Sec. 114-2852. Southeast Twenty-eighth Street--East Market Street to East Leach Avenue.**

Southeast Twenty-eighth Street, on the east side, from East Market Street to Maury Street, no parking any time.

Southeast Twenty-eighth Street, on the west side, from Maury Street to C.B. & Q. Street, no parking any time.

Southeast Twenty-eighth Street, on the east, from East Leach Avenue north to and including the cul-de-sac, no parking any time.

**Sec. 114-2944.01. East Fifty-second Street--Brook View Drive to Dead End.**

East Fifty-second Street, on the west side, from Brook View Drive south to the dead end, no parking any time.

**Sec. 114-2946.01. East Fifty-third Court--  
Brook View Avenue to dead end.**

East Fifty-third Court, on the west side,  
from Brook View Avenue south to the dead  
end, no parking any time.

**Sec. 114-3033.01. Brook Ridge Court--East  
Douglas Avenue to dead end.**

Brook Ridge Court, on the west side, from  
East Douglas Avenue south to the dead end,  
no parking any time.

**Sec. 114-3033.05. Brook View Avenue--Brook  
Ridge Court to dead end.**

Brook View Avenue, on the north side, from  
Brook Ridge Court east to the dead end, no  
parking any time.

**Sec. 114-3033.09. Brook View Drive--Brook  
Ridge Court to dead end.**

Brook View Drive, on the west side, from  
Brook Ridge Court south to the dead end, no  
parking any time.

**Sec. 114-3225. Garfield Avenue--East Ninth  
Street to East Thirty-seventh Court.**

Garfield Avenue, on the south side, from  
East Ninth Street to Idaho Street, no  
parking any time.

Garfield Avenue, on the south side, from Idaho Street to a point 100 feet east thereof, passenger loading and unloading.

Garfield Avenue, on the south side, from a point 100 feet east of Idaho Street to a point 100 feet east thereof, bus loading and unloading.

Garfield Avenue, on the north side, from a point 75 feet west of East Thirteenth Street to a point 75 feet east of East Thirteenth Street, no parking any time.

Garfield Avenue, on the north side, from a point 50 feet west of East Fourteenth Street to a point 50 feet east of East Fourteenth Street, no parking any time.

Garfield Avenue, on the south side, from a point 200 feet east of Idaho Street to East Fifteenth Street, passenger loading and unloading.

Garfield Avenue, on the north side, from East Seventeenth Street to McCormick Street, no parking any time.

Garfield Avenue, on the south side, from East Fifteenth Street to East Eighteenth Street, no parking any time.

Garfield Avenue, on the north side, from Idaho Street to East Fifteenth Street, no stopping or standing 7:00 a.m. to 5:00 p.m. school days.

Garfield Avenue, on the north side, from a point 30 feet west of Dixon Street to a point 60 feet east of Dixon Street, no parking any time.

Garfield Avenue, on the south side, from East Twenty-second Street to Avenue Frederick M. Hubbell, no parking any time.

Garfield Avenue, on the south side, from a point 50 feet west of East Twenty-third Street to a point 50 feet east of East Twenty-third Street, no parking any time.

Garfield Avenue, on the north side, from Avenue Frederick M. Hubbell to a point 120 feet east of East Twenty-fifth Street, no parking any time.

Garfield Avenue, on the south side, from East Twenty-fifth Street to East Thirty-third Street, no parking any time.

Garfield Avenue, on the north side, from East Thirtieth Street to a point 55 feet west thereof, no parking any time.

Garfield Avenue, on the south side, from East Thirty-fourth Street to East Thirty-sixth Street, no parking any time.

Garfield Avenue, on the north side, from East Thirty-fifth Street to a point 50 feet east thereof, no parking any time.

Garfield Avenue, on the north side, from East Thirty-seventh Street to East Thirty-seventh Court, no parking any time.

Garfield Avenue, on the south side, from East Thirty-seventh Court to a point 50 feet west thereof, no parking any time.

**Sec. 114-3401. East Leach Avenue--Southeast Sixteenth Street to East Watrous Avenue.**

East Leach Avenue, on the north side, from Southeast Sixteenth Street to Southeast Seventeenth Street, no parking any time.

East Leach Avenue, on the south side, from Southeast Twenty-fourth Court to East Watrous Avenue, no parking any time.

**Sec. 114-3464. East Marion Street--Southeast First Street to Southeast Twenty-sixth Street.**

East Marion Street, on the south side, from Southeast First Street to Southeast Second Street, no parking any time.

East Marion Street, on the north side, from Southeast Third Street to Southeast Fifth Street, no parking any time.

East Marion Street, on the north side, from Southeast Tenth Street to Southeast Twelfth Street, no parking any time.

East Marion Street, on the south side, from East Indianola Avenue to Southeast Nineteenth Street, no parking any time.

East Marion Street, on the north side, from Southeast Twenty-second Street to Southeast Twenty-third Street, no parking any time.

East Marion Street, on the south side, from Southeast Twenty-second Street to a point 50 feet east thereof, no parking any time.

East Marion Street, on the south side, from Southeast Twenty-third Court to Southeast Twenty-fourth Street, no parking any time.

East Marion Street, on the south side, from Southeast Twenty-fifth Street to Southeast Twenty-sixth Street, no parking any time.

**Sec. 114-3486.01. Meadow Wood Circle--Brook Ridge Court to dead end.**

Meadow Wood Circle, on the north side, from Brook Ridge Court west to and including the cul-de-sac, no parking any time.

**Sec. 114-3581.01. Pond View Circle--Brook Ridge Court to dead end.**

Pond View Circle, on the north side, from Brook Ridge Court west to and including the cul-de-sac, no parking any time.

**Sec. 114-3708.01. Village Run Avenue--East Fifty-second Street to dead end.**

Village Run Avenue, on the north side, from East Fifty-second Street east to the dead end, no parking any time.

**Sec. 114-3708.05. Village Run Drive--East Fifty-second Street to dead end.**

Village Run Drive, on the north side, from East Fifty-second Street west to the dead end, no parking any time.

Sec. 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
