

ORDINANCE NO. 13,972

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, by repealing Sections 114-306.1, 114-2156.5, 114-2640.5, 114-2661, 114-3212, 114-3440, 114-3441, 114-3448, 114-3505, 114-3927.5 thereof and enacting new Sections 114-306.1, 114-2156.5, 114-2640.5, 114-2661, 114-3212, 114-3440, 114-3441, 114-3448, 114-3505, 114-3927.5 and adding and enacting new Sections 114-1812.1, 114-3883.1 and 114-3885.1, relating to traffic and vehicles.

Be It Ordained by the City Council of the
City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, is hereby amended by repealing Sections 114-306.1, 114-319.3, 114-2156.5, 114-2640.5, 114-2661, 114-3212, 114-3440, 114-3441, 114-3448, 114-3505, 114-3927.5 thereof and enacting new Sections 114-1812.1, 114-3883.1 and 114-3885.1, relating to traffic and vehicles, as follows:

Sec. 114-306.01. Traffic lanes allocated.

No person shall operate a vehicle in violation of the signs erected or pavement markings installed giving notice of the allocation of lanes of the street designated in this section. The director of traffic and transportation shall cause necessary and appropriate signs to be posted or necessary pavement markings installed along the street designated as follows, informing the general public of the restrictions:

- 1) On Southeast First Street, from Riverside Drive to Edison Avenue, one lane northbound, one lane southbound, and the center lane northbound

and southbound left turn only.

(2) On Southeast First Street, from Riverside Drive to Indianola Avenue, two lanes southbound and one lane northbound.

(3) On Sixth Avenue, from Ascension Street to Euclid Avenue, two lanes northbound, two lanes southbound, and the center lane northbound and southbound left turn only.

(4) On Southwest Ninth Street, from West Street to Wade Street, one lane northbound, one lane southbound, and the center lane northbound and southbound left turn only.

(5) On Southwest Ninth Street, from a point 230 feet south of McKinley Avenue to a point 300 feet south thereof, two lanes northbound, two lanes southbound, and the center lane northbound and southbound left turn only.

(6) On Easton Boulevard, from East Twenty-second Street to Avenue Frederick M. Hubbell, two lanes eastbound and one lane westbound.

(7) On Bell Avenue, from 200 feet east of Fleur Drive to 150 feet west of Druid Hill Drive, one lane eastbound, one lane westbound, and center lane eastbound and westbound left-turn only.

(8) On Grand Avenue, from West Third Street to East Sixth Street, one lane eastbound and the remaining lanes westbound.

(9) On Crocker Street, from Sixteenth Street to Nineteenth Street, two lanes westbound and one lane eastbound.

(10) On Martin Luther King, Jr. Parkway, from Woodland Avenue to Center Street, two lanes southbound and one lane northbound.

(11) On University Avenue, from Twenty-fourth Street to Thirty-first Street, two lanes eastbound, two lanes westbound, and the center lane eastbound and westbound left turn only.

(12) On Beaver Avenue, from Urbandale Avenue to a point 290 feet north of Madison Avenue, and from Shawnee Avenue to Aurora Avenue, one lane northbound, one lane

southbound, and the center lane northbound and southbound left turn only.

(13) On Lower Beaver road, from Douglas Avenue to Valdez Drive (west leg), on lane northbound, one lane southbound, and the center lane northbound and southbound left turn only.

Sec. 114-1812.1. Loomis Avenue.

Loomis Avenue, from Southwest Ninth Street to Glover Avenue, westbound.

Sec. 114-2156.5. Burnham Avenue.

Burnham Avenue, at Southeast Third Street, stop.

Burnham Avenue, at Southwest Fifteenth Street, stop.

Sec. 114-2640.5. Sixth Avenue--Vine Street to Cherry Street.

Sixth Avenue, on the east side, from Vine Street to a point 317 feet south of Cherry Street, no parking any time.

Sixth Avenue, on the east side, from Cherry Street to a point 25 feet south thereof, no parking any time.

Sixth Avenue, on the east side, from a point 25 feet south of Cherry Street to a point 317 feet south thereof, no parking 7:00 a.m. to 9:00 a.m.

Sixth Avenue, on the east side, from a point 179 feet south of Cherry Street, to a point 50 feet south thereof, no parking any time.

Sixth Avenue, on the west side, from Vine Street to Cherry Street, no parking any time.

Sec. 114-2661. Seventh Street--Vine Street to Mulberry Street.

Seventh Street, on the west side, from Vine Street to a point 158 feet south of Mulberry Street, no parking any time.

Seventh Street, on the west side, from a point 28 feet south of Mulberry Street to a point 130 feet south thereof, no parking 7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m.

Seventh Street, on the west side, from Mulberry Street to a point 28 feet south thereof, no parking any time.

Seventh Street, on the east side, from Vine Street to a point 290 feet south of Cherry Street, no parking any time. Seventh Street, on the east side, from a point 18 feet south of Cherry Street to a point 272 feet south thereof, no parking 4:00 p.m. to 6:00 p.m.

Seventh Street, to the east side, from a point 88 feet south of Cherry Street to a point 133 feet south thereof, no parking any time.

Sec. 114-3212. Francis Avenue--Dead end east of Eighteenth Street to Sixty-second Street.

Francis Avenue, on the north side, from a point 370 feet east of Eighteenth Street to Martin Luther King, Jr. Parkway, no parking any time.

Francis Avenue, on the north side, from Thirtieth Street to a point 50 feet west thereof, no parking any time.

Francis Avenue, on the north side, from a point 50 feet west of Thirtieth Street to a point 450 feet west thereof school passenger loading and unloading, 7:00 a.m. to 5:00 p.m., school days.

Francis Avenue, on the north side, from a point 500 feet west of Thirtieth Street to Thirty-second Street, no parking any time.

Francis Avenue, on the south side, from Thirtieth Street to 75 feet west of Thirtieth Street, no parking any time.

Francis Avenue, on the south side, from a point 75 feet west of Thirtieth Street to Thirty-second Street, no stopping or standing, 7:00 a.m. to 5:00 p.m., school days.

Francis Avenue, on the north side, from Fifty-fifth Street to Merklin Way, no parking any time.

Francis Avenue, on the south side, from Merle Hay Road to Fifty-ninth Street, no parking any time.

Francis Avenue, on the south side, from Sixty-first Street to Sixty-second Street, no parking any time.

Sec. 114-3440. Loomis Avenue--South Union Street to dead end west of Heliotrope Drive.

Loomis Avenue, on the north side, from a point 130 feet east of Southwest Fourth Place to a point 460 feet east thereof, no parking any time.

Loomis Avenue, on the north side, from Southwest Ninth Street to a point 200 feet east thereof, no parking any time.

Loomis Avenue, on the south side, from South Union Street to Southwest Ninth Street, no parking any time.

Loomis Avenue, on the north side, from Southwest Ninth Street to a point 50 feet west thereof, no parking any time.

Loomis Avenue, on the north side, from a point 50 feet west of Southwest Ninth Street to a point 110 feet west thereof, no parking 7:00 a.m. to 6:00 p.m., Monday through Friday.

Loomis Avenue, on the north side, from a point 160 feet west of Southwest Ninth Street to a point 80 feet west thereof is designated as handicapped parking and is subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

Loomis Avenue, on the north side, from a point 240 feet west of Southwest Ninth Street to a point 140 feet east of Southwest Twelfth Street, passenger loading and unloading only, 7:00 a.m. to 5:00 p.m., school days.

Loomis Avenue, on the north side, from Southwest Twelfth Street to a point 50 feet east thereof, no parking any time.

Loomis Avenue, on the south side, from Southwest Ninth Street to Southwest Twelfth Street, no stopping or standing.

Loomis Avenue, on the south side, from Southwest Twelfth Street to a point 280 feet west of Heliotrope Drive, no parking any time.

Sec. 114-3441. Lower Beaver Road--Douglas Avenue to north city limits.

Lower Beaver Road, on the east side, from Douglas Avenue to a point 65 feet north of Madison Avenue, no parking any time.

Lower Beaver Road, on the west side, from Douglas Avenue to a point 75 feet north of Madison Avenue, no parking any time.

Lower Beaver Road, on the west side, from a point 75 feet north of Madison Avenue to a point 370 feet north thereof, school passenger loading and unloading 7:00 a.m. to 5:00 p.m. school days.

Lower Beaver Road, on the west side, from a point 445 feet north of Madison Avenue to Valdez Drive (west leg), no parking any time.

Lower Beaver Road, on the west side, from Oaklyn Drive to a point 75 feet north thereof, no parking any time.

Lower Beaver Road, on the east side, from a point 65 feet north of Madison Avenue to a point 380 feet north thereof, school passenger loading and unloading, 7:00 a.m. to 5:00 p.m. school days.

Lower Beaver Road, on the east side, from a point 445 feet north of Madison Avenue to Valdez Drive (west leg), no parking any time.

Lower Beaver Road, on the east side, from Bel-Aire Road to a point 75 feet south thereof, no parking any time.

Sec. 114-3448. Madison Avenue--First Street to Sixteenth Street.

Madison Avenue, on the north side, from a point 110 feet east of Second Avenue to a

point 110 feet west of Second Avenue, no parking any time.

Madison Avenue, on the south side, from First Street to Sixteenth Street, no parking any time.

Madison Avenue, on the north side, from a point 150 feet east of Sixth Avenue to a point 70 feet west of Sixth Avenue, no parking any time.

Madison Avenue, on the north side, from Seventh Street to a point 50 feet west thereof, no parking any time.

Madison Avenue, on the north side, from a point 50 feet east of Ninth Street to a point 50 feet west of Ninth Street, no parking any time.

Madison Avenue, on the north side, from a point 50 feet east of Eleventh Street to a point 100 feet west of Eleventh Street, no parking any time.

Madison Avenue, on the north side, from Twelfth Street to a point 50 feet east thereof, no parking any time.

Sec. 114-3505. Mulberry Street--Sixth Avenue to Seventh Street.

Mulberry Street, on the south side, from Sixth Avenue to a point 18 feet west thereof no parking any time.

Mulberry Street, on the south side, from a point 18 feet west of Sixth Avenue to a point 16 feet east of Seventh Street, no parking 7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m.

Mulberry Street, on the south side, from a point 122 feet west of Sixth Avenue to a

point 75 feet west thereof, no parking any time.

Mulberry Street, on the south side, from Seventh Street to a point 16 feet east thereof, no parking any time.

Mulberry Street, on the north side, from Sixth Avenue to a point 195 feet west thereof, no parking any time.

Mulberry Street, on the north side, from a point 195 feet west of Sixth Avenue to Seventh Street, commercial loading zone.

Mulberry Street, on the north side, from a point 195 feet west of Sixth Avenue to Seventh Street, no parking 4:00 p.m. to 9:00 a.m.

Sec. 114-3883.1. Sixth Avenue--Market Street to Cherry Street.

Sixth Avenue, on the east side, from a point 229 feet south of Cherry Street to a point 88 feet south thereof, four-hour meters, 9:00 a.m. to 6:00 p.m.

Sixth Avenue, on the east side, from a point 25 feet south of Cherry Street to a point 154 feet south thereof, two-hour meters, 9:00 a.m. to 6:00 p.m.

Sec. 114-3885.1. Seventh Street--Market Street to Mulberry Street.

Seventh Street, on the west side, from a point 28 feet south of Mulberry Street to a point 130 feet south thereof, two-hour meters, 9:00 a.m. to 4:00 p.m.

Seventh Street, on the east side, from a point 169 feet south of Mulberry Street to a point 125 feet south thereof, four-hour meters, 9:00 a.m. to 4:00 p.m.

Seventh Street, on the east side, from a point 18 feet south of Cherry Street to a point 70 feet south thereof, four-hour meters, 8:00 a.m. to 4:00 p.m.

Seventh Street, on the east side, from a point 221 feet south of Cherry Street to a point 69 feet south thereof, four-hour meters, 8:00 a.m. to 4:00 p.m.

Sec. 114-3927.5. Mulberry Street--Sixth Avenue to Seventh Avenue.

Mulberry Street, on the south side, from a point 18 feet west of Sixth Avenue to a point 104 feet west thereof, two-hour meters, 9:00 a.m. to 4:00 p.m.

Mulberry Street, on the south side, from a point 197 feet west of Sixth Avenue to a point 94 feet west thereof, two-hour meters, 9:00 a.m. to 4:00 p.m.

Sec. 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
