

ORDINANCE NO. 14,012

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, by repealing Sections 114-2760, 114-3246, 114-3628 and 114-3912 thereof and enacting new Sections 114-2760, 114-3246, 114-3628 and 114-3912, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, is hereby amended by repealing Sections 114-2760, 114-3246, 114-3628 and 114-3912 thereof and enacting new Sections 114-2760, 114-3246, 114-3628 and 114-3912, relating to traffic and vehicle regulations, as follows:

**Sec. 114-2760. Fifteenth Street--Ingersoll Avenue to dead end north of Shawnee Avenue.**

Fifteenth Street, on the west side, from a point 75 feet south of Ingersoll Avenue to a point 120 feet north of Ingersoll Avenue, no parking any time.

Fifteenth Street, on the east side, from Ingersoll Avenue to High Street, no parking any time.

Fifteenth Street, on both sides, from High Street to a point 50 feet north thereof, no parking any time.

Fifteenth Street, on both sides, from Woodland Avenue to a point 50 feet south thereof, no parking any time.

Fifteenth Street, on the east side, from Woodland Avenue to a point 250 feet north of Center Street, no parking 7:00 a.m. to 6:00 p.m.

Fifteenth Street, on the west side, from Woodland Avenue to a point 50 feet north thereof, no parking any time.

Fifteenth Street, on the west side, from a point 50 feet north of Woodland Avenue to a point 75 feet south of Pleasant Street, no parking 7:00 a.m. to 9:00 a.m.

Fifteenth Street, on the west side, from a point 75 feet south of Pleasant Street to a point 100 feet north of Pleasant Street, no parking any time.

Fifteenth Street, on the west side, from a point 75 feet south of Park Street to a point 100 feet north of Park Street, no parking any time.

Fifteenth Street, on the west side, from a point 75 feet south of Center Street to a point 100 feet north of Center Street, no parking any time.

Fifteenth Street, on both sides, from a point 250 feet north of Center Street to Sixteenth Street, no parking any time.

Fifteenth Street, on both sides, from Crocker Street to a point 300 feet south of School Street, no parking, 10:00 p.m. to 7:00 a.m.

Fifteenth Street, on both sides, from School Street to a point 300 feet south thereof, no parking any time.

Fifteenth Street, on the east side, from University Avenue to a point 150 feet north thereof, no parking any time.

Fifteenth Street, on the west side, from University Avenue to Carpenter Avenue, no parking any time.

Fifteenth Street, on the east side, from Douglas Avenue to Shawnee Avenue, no parking any time.

Fifteenth Street, on the west side, from Seneca Avenue to a point 50 feet south thereof, no parking any time.

Fifteenth Street, on the west side, from Shawnee Avenue to a point 550 feet north thereof and on any part of the cul-de-sac, no parking any time.

**Sec. 114-3246. Grand Avenue--Third Street to Fourth Street.**

Grand Avenue, on the south side, from Third Street to a point 170 feet west thereof, no parking 7:00 a.m. to 9:00 a.m.

Grand Avenue, on the south side, from a point 170 feet west of Third Street to Fourth Street, no parking any time.

Grand Avenue, on the north side, from Third Street to a point 15 feet west thereof, no parking any time.

Grand Avenue, on the north side, from a point 15 feet west of Third Street to a point 30 feet west thereof, commercial loading zone, 9:00 a.m. to 4:00 p.m., Monday through Friday.

Grand Avenue, on the north side, from Third Street to Fourth Street, no parking 7:00 a.m. to 9:00 a.m.

Grand Avenue, on the north side, from Third Street to Fourth Street, no parking 4:00 p.m. to 6:00 p.m.

**Sec. 114-3628. Seneca Avenue--First Street to Forty-ninth Street.**

Seneca Avenue, on the north side, from First Street to Sixth Avenue, no parking any time.

Seneca Avenue, on the south side, from a point 50 feet east of Second Avenue to a point 50 feet west of Second Avenue, no parking any time.

Seneca Avenue, on the south side, from Sixth Avenue to Eleventh Street, no parking any time.

Seneca Avenue, on the south side, from Eleventh Street to Sixteenth Street, no parking any time.

Seneca Avenue, on the north side, from Fifteenth Street to a point 50 feet west thereof, no parking any time.

Seneca Avenue, on the north side, from Thirtieth Street to Lower Beaver Road, no parking any time.

Seneca Avenue, on the south side, from Lower Beaver Road to Thirty-sixth Street, no parking any time.

Seneca Avenue, on the north side, from Lower Beaver Road to a point 50 feet west thereof, no parking any time.

Seneca Avenue, on the north side, from Forty-eighth Street to Forty-ninth Street, no parking any time.

**Sec. 114-3912. Grand Avenue--Third Street to Fourth Street.**

Grand Avenue, on the south side, from Third Street to a point 170 feet west thereof, two-hour meters, 9:00 a.m. to 6:00 p.m., Monday through Friday.

Grand Avenue, on the north side, from a point 45 feet west of Third Street to Fourth Street, two-hour meters, 9:00 a.m. to 4:00 p.m., Monday through Friday.

Sec. 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
