

ORDINANCE NO. 14,038

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, and amended by Ordinance 14,025, passed December 3, 2001, by repealing Sections 114-2921, 114-2944, 114-3064 and 114-3169 thereof and enacting new Sections 114-2921, 114-2944, 114-3064 and 114-3169, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the
City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, and amended by Ordinance No. 14,025, passed December 3, 2001, is hereby amended by repealing Sections 114-2921, 114-2944, 114-3064 and 114-3169 thereof and enacting new Sections 114-2921, 114-2944, 114-3064 and 114-3169, relating to traffic and vehicle regulations, as follows:

**Sec. 114-2921. Forty-first Street--Grand
Avenue to north city limits.**

Forty-first Street, on the east side, from Grand Avenue to Ingersoll Avenue, no parking any time.

Forty-first Street, on the east side, from Ingersoll Avenue to a point 30 feet north thereof, no parking any time.

Forty-first Street, on the west side, from Ingersoll Avenue to Center Street, no parking any time.

Forty-first Street, on the east side, from University Avenue to Forest Avenue, no parking any time.

Forty-first Street, on the west side, from University Avenue to a point 125 feet north thereof, no parking any time.

Forty-first Street, on the west side, from a point 125 feet north of University Avenue to

Forest Avenue, no parking 7:00 a.m. to 6:00 p.m.

Forty-first Street, on the east side, from a point 50 feet south of Northwest Drive to a point 75 feet north of Northwest Drive, no parking any time.

Forty-first Street, on the west side, from Forest Avenue to Beaver Avenue, no parking any time.

Forty-first Street, on the east side, from a point 100 feet south of College Avenue to a point 100 feet north of College Avenue, no parking any time.

Forty-first Street, on the east side, from Germania Drive to a point 85 feet south thereof, no parking any time.

Forty-first Street, on the east side, from Beaver Avenue to a point 150 feet south thereof, no parking any time.

Forty-first Street, on the east side, from Douglas Avenue to a point 50 feet north thereof, no parking any time.

Forty-first Street, on the west side, from Douglas Avenue to Shawnee Avenue, no parking any time.

Forty-first Street, on the west side, from Aurora Avenue to a point 730 feet north thereof, no parking any time.

Forty-first Street, on the east side, from Aurora Avenue to a point 50 feet north thereof, no parking any time.

**Sec. 114-2944. Fifty-second Street--
Robertson Drive to Aurora Avenue.**

Fifty-second Street, on the west side, from Robertson Drive to a point 120 feet north thereof, no parking any time.

Fifty-second Street, on the east side, from Robertson Drive to a point 720 feet north thereof, no parking any time.

Fifty-second Street, on the west side, from Woodland Avenue to Pleasant Street, no parking any time.

Fifty-second Street, on the east side, from Franklin Avenue to Hickman Road, no parking any time.

Fifty-second Street, on the west side, from Hickman Road to a point 50 feet south thereof, no parking any time.

Fifty-second Street, on the east side, from Urbandale Avenue to a point 50 feet north thereof, no parking any time.

Fifty-second Street, on the west side, from Urbandale Avenue to Aurora Avenue, no parking any time.

Fifty-second Street, on the east side, from Douglas Avenue to a point 530 feet south thereof, no parking 7:00 a.m. to 5:00 p.m. school days.

Fifty-second Street, on the east side, from Douglas Avenue to a point 50 feet north thereof, no parking any time.

Fifty-second Street, on the east side, from Madison Avenue to a point 50 feet north thereof, no parking any time.

Fifty-second Street, on the east side, from Aurora Avenue to a point 50 feet south thereof, no parking any time.

Sec. 114-3064. Center Street--Twenty-fourth Street to Thirty-fifth Street.

Center Street, on the north side, from Twenty-fourth Street to Twenty-fifth Street, no parking any time.

Center Street, on the south side, from Twenty-fourth Street to a point 25 feet east of Thirtieth Street, no parking 7:00 a.m. to 5:00 p.m. school days.

Center Street, on the south side, from a point 25 feet east of Thirtieth Street to a point 50 feet east of Thirty-first Street, bus loading and unloading 7:00 a.m. to 5:00 p.m. school days.

Center Street, on the south side, from a point 50 feet east of Thirty-first Street to a point 50 feet west of Thirty-first Street, no parking any time.

Center Street, on the north side, from Thirty-first Street to a point 75 feet east thereof, no parking any time.

Center Street, on the north side, from a point 75 feet east of Thirty-first Street to a point 115 feet east thereof, no stopping or standing 7:00 a.m. to 5:00 p.m. school days.

Center Street, on the north side, from Thirty-first Street to Thirty-fifth Street, no parking any time.

Center Street, on the south side, from Thirty-third Street to a point 75 feet west thereof, no parking any time.

Center Street, on the south side, from a point 125 feet east of Thirty-fifth Street to Thirty-fifth Street, no parking any time.

Sec. 114-3169. Easton Boulevard--East Twenty-second Street to East Twenty-ninth Street.

Easton Boulevard, on both sides, from East Twenty-second Street to a point 240 feet west thereof, no parking any time.

Easton Boulevard, on the south side, from East Twenty-second Street to East Twenty-ninth Street, no parking any time.

Easton Boulevard, on the north side, from East Twenty-second Street to a point 75 feet east thereof, no parking any time.

Easton Boulevard, on the north side, from Searle Street to a point 45 feet west thereof, no parking any time.

Easton Boulevard, on the north side, from a point 30 feet west of Lay Street to East Twenty-ninth Street, no parking any time.

Sec. 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
