

ORDINANCE NO. 14,047

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, by repealing Sections 114-2999 and 114-3897 thereof and enacting new Sections 114-2999 and 114-3897, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, is hereby amended by repealing Sections 114-2999 and 114-3897 thereof and enacting new Sections 114-2999 and 114-3897, relating to, traffic and vehicle regulations, as follows:

**Sec. 114-2999. Aurora Avenue--Lower Beaver Road to west city limits.**

Aurora Avenue, on the south side, from Lower Beaver Road to Forty-third Street, no parking any time.

Aurora Avenue, on the north side, from Fortieth Street to a point 50 feet west thereof, no parking any time.

Aurora Avenue, on the south side, from Beaver Avenue to a point 170 feet west of Forty-second Street, no parking any time.

Aurora Avenue, on the north side, from Forty-sixth Street to a point 50 feet west thereof, no parking any time.

Aurora Avenue, on the south side, from a point 170 feet west of Forty-seventh Street to a point 500 feet west thereof, school bus loading and unloading 7:00 a.m. to 5:00 p.m. school days.

Aurora Avenue, on the north side, from Forty-seventh Street to a point 75 feet east of Forty-eighth Street, no parking 7:00 a.m. to 6:00 p.m., Monday through Saturday.

Aurora Avenue, on the north side, from a point 75 feet east of Forty-eighth Street to a point 75 feet west of Forty-eighth Street, no parking any time.

Aurora Avenue, on the north side, from a point 75 feet west of Forty-eighth Street to a point 400 feet west thereof, no parking 7:00 a.m. to 6:00 p.m., Monday through Saturday.

Aurora Avenue, on the north side, from a point 855 feet west of Forty-eighth Street to a point 75 feet west thereof, no parking any time.

Aurora Avenue, on the north side, from a point 400 feet west of Forty-eighth Street to Fiftieth Street, no parking any time.

Aurora Avenue, on the north side, from Fiftieth Street to Merle Hay Road, no parking any time.

Aurora Avenue, on the south side, from Merle Hay Road to a point 950 feet east of Fiftieth Street, no parking any time.

Aurora Avenue, on the south side, from Merle Hay Road to a point 1,290 feet west thereof, no parking any time.

**Sec. 114-3897. Tenth Street--High Street to Woodland Avenue.**

Tenth Street, on the west side, parking meter 10-601, 10-603 and 10-604 four-hour meters, 8:00 a.m. to 6:00 p.m., are designated handicapped parking spaces and are subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

Tenth Street, on the west side, from a point 25 feet north of High Street to a point 35 feet south of Woodland Avenue, four-hour meters, 8:00 a.m. to 6:00 p.m.

Tenth Street, on the east side, from High Street to a point 140 feet north thereof, four-hour meters, 8:00 a.m. to 4:00 p.m.

Tenth Street, on the east side, from a point 230 feet north of High Street to Woodland Avenue, four-hour meters, 8:00 a.m. to 4:00 p.m.

Sec. 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
