

ORDINANCE NO. 14,080

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, by repealing Sections 114-1264, 114-1343, 114-1362, 114-1451, 114-1497, 114-2083, 114-2303, 114-2357, 114-2483, 114-2532, 114-2543, 114-2818, 114-2853, 114-2865, 114-3659 and 114-3704 thereof and enacting new Sections 114-1264, 114-1343, 114-1451, 114-2083, 114-2303, 114-2483, 114-2532, 114-2818, 114-2853, 114-2865, and 114-3659, and adding and enacting new Sections 114-1318.01, 114-1454.01, 114-2213.01, 114-2510.01, and 114-3226.01 relating to the renaming of Valley Drive to George Flagg Parkway.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, is hereby amended by repealing Sections 114-1264, 114-1343, 114-1362, 114-1451, 114-1497, 114-2083, 114-2303, 114-2357, 114-2483, 114-2532, 114-2543, 114-2818, 114-2853, 114-2865, 114-3659 and 114-3704 thereof and enacting new Sections 114-1264, 114-1343, 114-1451, 114-2083, 114-2303, 114-2483, 114-2532, 114-2818, 114-2853, 114-2865, and 114-3659, and adding and enacting new Sections 114-1318.01, 114-1454.01, 114-2213.01, 114-2510.01, and 114-3226.01 relating to the renaming of Valley Drive to George Flagg Parkway, as follows:

Sec. 114-1264. Southwest Thirtieth Street.

Southwest Thirtieth Street, from George Flagg Parkway to Park Avenue, 30 miles per hour.

Sec. 114-1318.01. George Flagg Parkway.

George Flagg Parkway, from Fleur Drive to Southwest Thirtieth Street, 35 miles per hour.

George Flagg Parkway, from Southwest Thirtieth Street to Park Avenue, 40 miles per hour.

Sec. 114-1343. Park Avenue.

Park Avenue, from South Union Street to Southwest Fourteenth Street, 30 miles per hour.

Park Avenue, from Southwest Fourteenth Street to Fleur Drive, 35 miles per hour.

Park Avenue, from Fleur Drive to George Flagg Parkway, 30 miles per hour.

Park Avenue, from George Flagg Parkway to Southwest Sixty-third Street, 35 miles per hour.

Fleur Drive and Grays Lake Park Road, traffic control signal.

Fleur Drive and George Flagg Parkway, traffic control signal.

Fleur Drive and Watrous Avenue, traffic control signal.

Fleur Drive and McKinley Avenue, traffic control signal.

Sec. 114-1454.01. George Flagg Parkway.

George Flagg Parkway and Fleur Drive,
traffic control signal.

Sec. 114-2083. Southwest Thirtieth Street.

Southwest Thirtieth Street, from the south
line of George Flagg Parkway to the north
line of Park Avenue, stop.

Sec. 114-2213.01. George Flagg Parkway.

George Flagg Parkway, from the south line of
Park Avenue to the west line of Fleur Drive,
stop.

The driver of a vehicle southbound on Fleur
Drive using the connecting roadway to turn
right at George Flagg Parkway shall yield
the right-of-way to westbound traffic on
George Flagg Parkway, yield.

Sec. 114-2303. Park Avenue.

Park Avenue, from the west line of South
Union Street to the west corporate limits,
stop.

The driver of a vehicle westbound on George
Flagg Parkway at Park Avenue shall yield the
right-of-way to westbound traffic on Park
Avenue, yield.

Sec. 114-2483. Southwest Thirtieth Street.

Southwest Thirtieth Street, from George Flagg Parkway to Bell Avenue.

Sec. 114-2510.01. George Flagg Parkway.

George Flagg Parkway, from Fleur Drive to Park Avenue.

Sec. 114-2532. Park Avenue.

Park Avenue, from George Flagg Parkway to Southwest Sixty-third Street.

Sec. 114-2543. Repealed by Ord. No. 14,---.

Sec. 114-2818. Southwest Twenty-third Street--George Flagg Parkway to Park Avenue.

Southwest Twenty-third Street, on the east side, from Bell Avenue to Park Avenue, no parking any time.

Southwest Twenty-third Street, on the west side, from Bell Avenue to a point 100 feet south thereof, no parking any time.

Southwest Twenty-third Street, on the west side, from George Flagg Parkway to Sunset Road, no parking any time.

Sec. 114-2853. Southwest Twenty-eighth Street--George Flagg Parkway to dead end south of Summit Vista Drive.

Southwest Twenty-eighth Street, on the west side, from George Flagg Parkway to Sunset Road, no parking any time.

Southwest Twenty-eighth Street, on the west side, from Park Avenue to Thornton Avenue, no parking any time.

Southwest Twenty-eighth Street, on the east side, from Wolcott Avenue to a point 500 feet south thereof, no parking any time.

Southwest Twenty-eighth Street, on the east side, from Watrous Avenue to a point 150 feet south of Summit Vista Drive, no parking any time.

Sec. 114-2865. Southwest Thirtieth Street--George Flagg Parkway to dead end south of Summit Vista Drive.

Southwest Thirtieth Street, on the east side, from George Flagg Parkway to Park Avenue, no parking any time.

Southwest Thirtieth Street, on the east side, from a point 230 feet north of Wolcott Avenue and any part of the cul-de-sac to Rose Avenue, no parking any time.

Southwest Thirtieth Street, on the east side, from Watrous Avenue to a point 150 feet south of Summit Vista Drive, no parking any time.

Sec. 114-3226.01. George Flagg Parkway--Fleur Drive to Park Avenue.

George Flagg Parkway, on the north side, from Fleur Drive to a point 50 feet west thereof, no parking any time.

George Flagg Parkway, on the south side, from Fleur Drive to Park Avenue, no parking any time.

Sec. 114-3659. Sunset Drive--Fleur Drive to Southwest Twenty-eighth Street.

Sunset Drive, on the east side, from George Flagg Parkway to a point 415 feet south thereof, no parking any time.

Sunset Drive, on the west and north sides, from George Flagg Parkway to Southwest Twenty-third Street, no parking any time.

Sunset Drive, on both sides, from Southwest Twenty-third Street to Southwest Twenty-eighth Street, no parking any time.

Sec. 114-3704. Repealed by Ord. No. 14,---
