

ORDINANCE NO. 14,139

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, and amended by Ordinance No. 14,062, passed March 18, 2002, by repealing Sections 114-3115, 114-3428, 114-3576, 114-3581, 114-3747, 114-3758, 114-4091 and 114-4110 thereof and enacting new Sections 114-3115, 114-3428, 114-3576, 114-3581, 114-3747 and 114-3758, and adding and enacting a new Section 114-3538.01, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the
City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, and amended by Ordinance No. 14,062, passed March 18, 2002, is hereby amended by repealing Sections 114-3115, 114-3428, 114-3576, 114-3581, 114-3747, 114-3758, 114-4091 and 114-4110 thereof and enacting new Sections 114-3115, 114-3428, 114-3576, 114-3581, 114-3747 and 114-3758, and adding and enacting a new Section 114-3538.01, relating to traffic and vehicle regulations, as follows:

**Sec. 114-3115. East Court Avenue--First
Street to East Second Street.**

East Court Avenue, on both sides, from East First Street to a point 95 feet west thereof, no parking any time.

East Court Avenue, on the south side, from East First Street to a point 50 feet west of East Second Street, reserved for official police vehicles.

East Court Avenue, on the north side, from a point 165 feet east of East First Street to a point 40 feet east thereof, loading zone.

East Court Avenue, on the south side, from East Second Street to a point 50 feet west thereof, no parking any time.

East Court Avenue, on the north side, from East First Street to a point 165 feet east thereof, no stopping or standing.

East Court Avenue, on the north side, from a point 205 feet east of East First Street to East Second Street, no stopping or standing.

East Court Avenue, on the north side, from East Second Street to a point 75 feet west thereof, no parking any time.

Sec. 114-3428. Locust Street--Tenth Street to Eleventh Street.

Locust Street, on the north side, from Tenth Street, to a point 40 feet west thereof, no parking 4:00 p.m. to 6:00 p.m. and 10:00 p.m. to 9:00 a.m.

Locust Street, on the north side, from Tenth Street, to a point 25 feet west thereof, no parking any time.

Locust Street, on the south side, from Tenth Street to a point 215 feet west, no parking any time.

Locust Street, on the south side, from a point 215 feet west of Tenth Street to Eleventh Street, no parking 7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m.

Locust Street, on the south side, from a point 110 feet west of Eleventh Street to a point 60 feet west thereof, commercial loading zone.

Locust Street, on the south side, from Tenth Street to Eleventh Street, no parking any time.

Locust Street, on the north side, from a point 120 feet west of Tenth Street to a point 25 feet west thereof, commercial loading zone.

Locust Street, on the north side, from a point 40 feet west of Tenth Street to

Eleventh Street, no parking 10:00 p.m. to 9:00 a.m.

Sec. 114-3538.01. Oneida Point--Southwest Thirty-seventh Street to Southwest Thirty-eighth Place.

Oneida Point, on the north side, from Southwest Thirty-seventh Street west to and including the cul-de-sac, no parking any time.

Sec. 114-3576. Pleasant Street--Twenty-fourth Street to Sixty-third Street.

Pleasant Street, on the south side, from Twenty-fourth Street to Twenty-eighth Street, no parking any time.

Pleasant Street, on the south side, from Thirty-first Street to Thirty-sixth Street, no parking any time.

Pleasant Street, on the north side, from Thirty-first Street to a point 50 feet west thereof, no parking any time.

Pleasant Street, on the north side, from Thirty-ninth Street to Forty-second Street, no parking any time.

Pleasant Street, on the south side, from Forty-second Street to a point 180 feet east thereof, no parking any time.

Pleasant Street, on the south side, from Forty-fourth Street to a point 100 feet east thereof, no parking any time.

Pleasant Street, on the north side, from Forty-fourth Street to Bradway Place, no parking any time.

Pleasant Street, on the north side, from Polk Boulevard to a point 50 feet west thereof, no parking any time.

Pleasant Street, on the south side, from Polk Boulevard to Fifty-second Street, no parking any time.

Sec. 114-3581. Polk Boulevard--Grand Avenue to University Avenue.

Polk Boulevard, on the west side, from Grand Avenue to a point 75 feet north thereof, no parking any time.

Polk Boulevard, on the west side, from Woodland Avenue to a point 75 feet north thereof, no parking any time.

Polk Boulevard, on the west side, from Pleasant Street to a point 50 feet south thereof, no parking any time.

Polk Boulevard, on both sides, from Pleasant Street to Center Street, no parking any time.

Polk Boulevard, on the east side, from Center Street to a point 50 feet north thereof, no parking any time.

Polk Boulevard, on the east side, from Chamberlain Drive to a point 50 feet south thereof, no parking any time.

Polk Boulevard, on the west side, from Chamberlain Drive to a point 50 feet north thereof, no parking any time.

Polk Boulevard, on the east side, from Boulevard Place to a point 50 feet south thereof, no parking any time.

Polk Boulevard, on the west side, from a point 140 feet south of University Avenue to

a point 35 feet south thereof, is designated a handicapped parking space and is subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

Polk Boulevard, on the east side, from University Avenue to a point 200 feet south thereof, no parking any time.

Sec. 114-3747. East Walnut Street--East First Street to East Second Street.

East Walnut Street, on the south side, from East First Street to a point 140 feet east thereof, no stopping or standing.

East Walnut Street, on the south side, from a point 190 feet east of East First Street to Second Street, no stopping or standing.

East Walnut Street, on the south side, from a point 140 feet east of East First Street to a point 50 feet east thereof, loading zone.

Sec. 114-3758. Waterbury Road--Polk Boulevard to Waterbury Circle.

Waterbury Road, on the south side, from Polk Boulevard to Forty-ninth Street, no parking any time.

Waterbury Road, on the north side, from Forty-eighth Street to a point 50 feet west thereof, no parking any time. Waterbury Road, on the north side, from Forty-ninth Street to Fifty-sixth Street, no parking any time.

Waterbury Road, on the north side, from Fifty-sixth Street to Fifty-seventh Street, no parking any time.

Waterbury Road, on the south side, from
Fifty-seventh Street to Waterbury Circle, no
parking any time.
