

ORDINANCE NO. 14,196

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, by amending Sections 114-2906 and 114-3500 of Chapter 114, Traffic and Vehicles, relating to traffic regulation changes.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, is hereby amended by amending Sections 114-2906 and 114-3500 of Chapter 114, Traffic and Vehicles, relating to traffic regulation changes, as follows:

**Sec. 114-2906. Thirty-eighth Street--  
Ingersoll Avenue to dead end north of  
Brinkwood Road.**

Thirty-eighth Street, on the east side, from Ingersoll Avenue to a point 200 feet north thereof, no parking any time.

Thirty-eighth Street, on the west side, from Ingersoll Avenue a point 60 feet north thereof, no parking any time.

Thirty-eighth Street, on the west side, from a point 60 feet north of Ingersoll Avenue to a point 95 feet north thereof, loading zone.

Thirty-eighth Street, on the west side, from a point 155 feet north of Ingersoll Avenue to Woodland Avenue, no parking any time.

Thirty-eighth Street, on the east side, from Woodland Avenue to Center Street, no parking any time.

Thirty-eighth Street, on the west side, from Kingman Boulevard to a point 50 feet south thereof, no parking any time.

Thirty-eighth Street, on the east side, from Cottage Grove Avenue to University Avenue, no parking any time.

Thirty-eighth Street, on the west side, from Beaver Avenue to Madison Avenue, no parking any time.

Thirty-eighth Street, on the east side, from Hickman Road to a point 50 feet north thereof, no parking any time.

Thirty-eighth Street, on the east side, from a point 310 feet south of Urbandale Avenue to a point 300 feet south thereof, no parking any time.

Thirty-eighth Street, on the east side, from a point 150 feet south of Douglas Avenue to a point 200 feet north of Douglas Avenue, no parking any time.

Thirty-eighth Street, on the east side, from Madison Avenue to a point 50 feet south thereof, no parking any time.

Thirty-eighth Street, on the east side, from Aurora Avenue to Lindlavista Way, no parking any time.

**Sec. 114-3500. Morton Avenue--Bowdoin Street to East Forty-first Street.**

Morton Avenue, on the south side, from East Ninth Street to a point 50 feet east thereof, no parking any time.

Morton Avenue, on the north side, from Bowdoin Street to East Fourteenth Street, no parking any time.

Morton Avenue, on the south side, from a point 75 feet east of East Thirteenth Street to a point 75 feet west of East Thirteenth Street, no parking any time.

Morton Avenue, on the south side, from East Fourteenth Street to a point 50 feet west thereof, no parking any time.

Morton Avenue, on the north side, from East Fourteenth Street to a point 50 feet east thereof, no parking any time.

Morton Avenue, on the south side, from East Fourteenth Street to a point 500 feet east thereof, no parking any time.

Morton Avenue, on the north side, from Idaho Street east to the dead end, no parking any time.

Morton Avenue, on the north side, from Delaware Avenue to a point 1200 feet east thereof, no parking any time.

Morton Avenue, on the south side, from East Twenty-fourth Street to a point 650 feet west thereof, no parking any time.

Morton Avenue, on the south side, from East Twenty-fifth Street to East Twenty-seventh Street, no parking any time.

Morton Avenue, on the north side, from East Twenty-seventh Street to a point 100 feet west thereof, no parking any time.

Morton Avenue, on the south side, from East Fortieth Street to East Forty-first Street, no parking any time.

Sec. 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
