- Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, and amended by Ordinance No. 13,855, passed August 21, 2000, and Ordinance No. 13,933, passed March 26, 2001, and Ordinance No. 13,997, passed September 24, 2001, and Ordinance No. 14,000, passed September 24, 2001, and Ordinance No. 14,060, passed March 4, 2002, and Ordinance No. 14,161, passed November 18, 2002, and Ordinance 14,197, passed January 6, 2003, and Ordinance No. 14,255, passed July 28, 2003, and Ordinance No. 14,322, passed March 22, 2004, is hereby amended by amending Sections 114-2638, 114-114-2655, 114-2682, 114-2718, 114-2895, 114-3015, 114-3039, 114-3093, 114-3148, 114-3236, 114-3429, 1143515, 114-3723, 114-3873, 114-3972 and 114-4086 and adding and enacting a new Section 14-2624.01 thereof, relating to traffic and vehicle regulations, as follows:

Sec. 114-2624.01. Southeast Fourth Street--Army Post road to East County Line Road.

Southeast Fourth Street, from Burnham Avenue south and any part of the cul-de-sac. no parking any time.

Sec. 114-2638. Southwest Fifth Street--Vine Street to Army Post Road.

Southwest Fifth Street, on the west side, from a point 100 feet south of Vine Street to a point 30 feet south thereof, commercial loading zone. Southwest Fifth Street, the east side, from Vine Street to a point 80 feet south thereof, no parking any time. Southeast Fifth Street, on the west side, from a point 40 feet north of Tuttle Street to a point 50 feet south of Tuttle Street, no parking any time. Southwest Fifth Street, on the east side, from Tuttle Street to a point 250 feet south thereof, no parking any time.

Southwest Fifth Street, on the west side, from Murphy Street to a point 50 feet north thereof, no parking any time. Southwest Fifth Street, on both sides, from Broad Street to Virginia Street, no parking any time. Southwest Fifth Street, on the east side, from Virginia Street to Pleasantview Drive, no parking any time. Southwest Fifth Street, on the east side, from a point 400 feet north of Park Avenue to Hughes Avenue, no parking any time. Southwest Fifth Street, on the east side, from Caulder Avenue to Thornton Street, no parking any time. Southwest Fifth Street, on the west side, from Caulder Avenue to a point 50 feet south thereof, no parking any time. Southwest Fifth Street, on the west side, from Watrous Avenue to Philip Street, no parking any time. Sec. 114-2655. East Sixth Street--East Grand Avenue to Des Moines Street.

Eighth Street, on the west side, from a point 35 feet south of College Avenue to a point 20 feet south thereof, is designated a handicapped parking space and is subject to the same prohibition as is found in section 114-616(a) of this Code. Eighth Street, on the east side, from Clark Street to a point 200 feet south of College Avenue, passenger loading and unloading. Eighth Street, on the east side, from College Avenue to a point 140 feet south thereof, no stopping or standing. Eighth Street, on the east side, from a point 140 feet south of College Avenue to a point 250 feet south thereof, bus loading and unloading. Eighth Street, on the west side, from a point 40 feet south of Franklin Avenue to Hickman Road, no parking any time. Eighth Street, on the east side, from a point 50 feet south of Franklin Avenue to a point 50 feet north of Franklin Avenue, no parking any time. Sec. 114-4086. East Sixth Street--East Grand Avenue to Des Moines Street.

East Sixth Street, on the west side, from a point 110 feet north of East Grand Avenue to Des Moines Street, four-hour meters, 8:00 a.m. to 6:00 p.m. East Sixth Street, on the east side, from East Grand Avenue to a point 60 feet north thereof, four-hour meters, 8:00 a.m. to 6:00 p.m. East Sixth Street, on the east side, from a point 110 feet north of East Grand Avenue Des Moines Street, four-hour meters, 8:00 a.m. to 6:00 p.m.
