AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, and amended by Ordinance No. 14,305, passed December 22, 2003 by amending Sections 74-59, 74-93, 74-100 and 74-114 and repealing Sections 74-60 and 74-184 thereof, relating to Blank Park Zoo.

Be It Ordained by the City Council of the City of Des Moines,

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, and amended by Ordinance No. 14,305, passed December 22, 2003 is hereby amended by amending Sections 74-59, 74-93, 74-100 and 74-114 and repealing Sections 74-60 and 74-184 thereof, relating to Blank Park Zoo relating to, as follows:

Sec. 74-59. Divisions enumerated.

The park and recreation department shall be composed of the following divisions:

- (1) Horticulture division.
- (2) Park division.
- (3) Cemetery division.
- (4) Recreation division.

Sec. 74-60. Repealed by Ord. No. 14,---.

Sec. 74-93. Destruction of plant or animal life.

No person, except persons authorized, shall in any manner deface, injure or remove any tree, shrub or plant standing or growing in any public park or recreation facility or pick or destroy any flowers or seeds growing therein. No person, except

persons authorized, shall remove or attempt to remove, injure, or kill any wild or captive animal in any public park or recreation facility.

Sec. 74-100. Dogs.

No dog shall be allowed to run at large in any public park. Any dog shall be deemed to be found running at large, unless the owner carries such dog or leads such dog by a chain, strap or rope not exceeding six feet in length or keeps any such dog confined in an automobile. However, a service dog, as defined in I.C. § 216C.11, especially trained to assist a blind or partially blind person and accompanying such person shall not be deemed to be running at large, even though restraints as described in this section are not used. Such person shall keep the service dog under control and shall be liable for any damage done to the premises or facilities by the dog. The park supervisor or any person in the city's employ shall remove and impound any dog running at large in any public park.

Sec. 74-114. Photographs and cinematic productions.

No person shall take still photographs for a commercial purpose or engage in cinematic production for any commercial purpose in any park, recreation facility or park road, exclusive of the Botanical Center or zoo, without a permit from the park and recreation director. No such permit shall be required of a commercial photographer who has been hired for the occasion to take still photographs or motion pictures of a group or gathering in any such locations.

Sec. 74-184. Repealed by Ord. No. 14,---.

Sec. 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
