

ORDINANCE NO. 14,608

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, and amended by Ordinance No. 13,924 passed February 26, 2001, and Ordinance No. 14,110 passed June 17, 2002, and Ordinance No. 14,244 passed June 23, 2003, and Ordinance No. 14,437 passed April 25, 2005, and Ordinance No. 14,458 passed June 6, 2005, and Ordinance No. 14,518 passed December 5, 2005, by amending Sections 114-361.01, 114-1894, 114-2938, 114-3206, 114-3506, 114-3506 and 114-3928, repealing Sections 114-1816, 114-1849 and 114-3927.7 and adding and enacting a new Section 114-61.1 thereof, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, and amended by Ordinance No. 13,924 passed February 26, 2001, and Ordinance No. 14,110 passed June 17, 2002, and Ordinance No. 14,244 passed June 23, 2003, and Ordinance No. 14,437 passed April 25, 2005, and Ordinance No. 14,458 passed June 6, 2005, and Ordinance No. 14,518 passed December 5, 2005 is hereby amended by amending Sections 114-361.01, 114-1894, 114-2938, 114-3206, 114-3506, 114-3506 and 114-3928, repealing Sections 114-1816, 114-1849 and 114-3927.7 and adding and enacting a new Section 114-61.1 thereof, relating to traffic and vehicle regulations, as follows:

Sec. 114-361.01. Angle parking.

- (a) The initiation of angle parking at any location where such parking is not in existence is prohibited except at the

following locations:

- (1) Bridal Row, on the east side, from Fifteenth Street to Pleasant Street.
 - (2) Court Avenue, on the south side, from Water Street to Fifth Avenue.
 - (3) Keosauqua Way, on both sides, from Sixth Avenue to Seventh Street.
 - (4) East First Street, on the east side, from Locust Street to Grand Avenue.
- (b) The initiation of back-in angle parking at any location is prohibited except as the following locations:
- (1) Court Avenue, on the south side, from Water Street to East Third Street.
 - (2) Walnut Street, on the north side, from Water Street to East First Street.
 - (3) East Fourth Street, on the west side, from Locust Street to Grand Avenue.
 - (4) East Fifth Street, on the east side, from Walnut Street to Grand Avenue.
- (c) When signs are erected giving notice thereof, no person shall park a vehicle in any parking space designated for back-in angle parking except by positioning their vehicle entirely within the marked space, with the rear of the vehicle to the curb side of the street and the front of the vehicle to the traveled lanes of the street.
- (d) Angle parking shall be permitted to continue at locations where the distance between the painted centerline and the parking curblines is equal to or greater than the minimum requirement established by the following formula:
- $$\begin{array}{l} \text{Minimum Width from Centerline} \\ \text{to Parking Curblines} \end{array} = \text{VAVE}/400 \times 10' + 19'$$
- (e) The letters "VAVE" as used in the formula in subsection (b) of this section represent the average hourly volume of cars during the four highest hours of a day.
- (f) The cost of installing and maintaining facilities for angle parking shall be borne by the abutting property owners, and if they or any of them shall fail to refuse to do so, the city reserves the right to withdraw the privilege of this method of parking.
- (g) Nothing within this section shall prohibit parking by more than one motorcycle within one parking space as otherwise provided in this chapter.
- (h) A person who violates any provision of this section shall pay a fine of \$15.00.

Sec. 114-671.1. 411 E. Grand Municipal Parking Lot.

- (a) The city engineer is hereby authorized to install parking meters in the following described municipally-owned parking lot: W. 20 Ft of Lot 4 and all of Lot 5, Block 9, East Fort Des Moines; in the City of Des Moines, Iowa for the purpose of, and in such numbers, and at such places as may be necessary to the regulation, control and inspection of the parking of vehicles therein, subject to division 6 of this article, regulating parking meters.
- (b) When installed, such parking meters shall be in operation between the hours of 8:00 a.m. and 6:00 p.m., Monday through Friday. Effective January 1, 2006 these parking meters shall conform to the parking meter rates listed Parking Meter District III, as is found in section 114-643 of this code.
- (c) The following rate shall be charged for reserved monthly parking 8:00 a.m. until 6:00 p.m., Monday through Friday.

Forty-eighth Street, on the east side, from Waterbury Road to a point 50 feet north thereof, no parking any time.

Forty-eighth Street, on the east side, from a point 50 feet north of Aurora Avenue to Merced Street, no parking 8:00 a.m. to 5:00 p.m. school days.

Forty-eighth Street, on the west side, from Aurora Avenue to Twana Drive, no parking any time.

Forty-eighth Street, on the east side, from Aurora Avenue to a point 50 feet north thereof, no parking any time.

Sec. 114-3206. Forest Avenue--Twenty-third Street to Thirtieth Street.

Forest Avenue, on the south side, from Twenty-third Street to Twenty-fourth Street, two-hour parking 9:00 a.m. to 4:00 p.m.

Forest Avenue, on the north side, from Twenty-fourth Street to Twenty-fifth Street, no parking 4:00 p.m. to 6:00 p.m.

Forest Avenue, on the north side, from Twenty-third Street to a point 50 feet west thereof, no parking any time.

Forest Avenue, on the north side, from a point 50 feet west of Twenty-third Street to a point 80 feet west thereof, no parking 4:00 p.m. to 6:00 p.m., Monday through Friday.

Forest Avenue, on the north side, from a point 130 feet west of Twenty-third Street to a point 140 feet west thereof, no parking 4:00 p.m. to 6:00 p.m., Monday through Friday.

Forest Avenue, on the north side, from a point 270 feet west of Twenty-third Street to a point 50 feet east of Twenty-fourth Street, no parking 4:00 p.m. to 6:00 p.m., Monday through Friday.

Forest Avenue, on the south side, from Twenty-third Street to a point 155 feet east of Twenty-seventh Street, no parking 7:00 a.m. to 9:00 a.m.

Forest Avenue, on the north side, from Twenty-fourth Street to a point 50 feet east thereof, no parking any time.

Forest Avenue, on the north side, from Twenty-fourth Street to Twenty-fifth Street, two-hour parking 9:00 a.m. to 4:00 p.m.

Forest Avenue, on the north side, from Twenty-fifth Street to a point 225 feet east of Twenty-ninth Street, no parking any time.

Forest Avenue, on the south side, from Twenty-fifth Street to Twenty-seventh Street, no parking any time.

Forest Avenue, on the south side, from a point 130 feet east of Twenty-seventh Street to a point 75 feet east of Thirtieth Street, no parking 7:00 a.m. to 9:00 a.m.

Sec. 114-3506. Mulberry Street--Seventh Street to Eighth Street.

Mulberry Street, on the south side, from Seventh Street to Eighth Street, no parking any time.

Sec. 114-3507. Mulberry Street--Eighth Street to Ninth Street.

Mulberry Street, on the north side, from Eighth Street to Ninth Street, no parking 7:00 a.m. to 9:00 p.m. and 4:00 p.m. to 6:00 p.m.

Mulberry Street, on the south side, from Eighth Street to Ninth Street, no parking any time.

Sec. 114-3928. Mulberry Street--Eighth Street to Ninth Street.

Mulberry Street, on the north side, from Eighth Street to Ninth Street, two-hour meters, 9:00 a.m. to 4:00 p.m.
