Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, and amended by Ordinance No. 13,973 passed July 23, 2001, and Ordinance No. 14,047 passed January 28, 2002, and Ordinance No. 14,121 passed July 16, 2002, and Ordinance No. 14,139 passed September 23, 2002, and Ordinance No. 14,322 passed March 22, 2004, and Ordinance No. 14,330 passed April 5, 2004, and Ordinance No. 14,371 passed September 13, 2004, and Ordinance No. 14,437 passed April 25, 2005, and Ordinance No. 14,486 passed September 12, 2005, and Ordinance No. 14,550

passed March 20, 2006, and Ordinance No. 14,635 passed March 12, 2007, and Ordinance No. 14,662 passed June 18, 2007 and Ordinance No. 14,722 passed November 19, 2007 is hereby amended by amending Sections 114-2703, 114-2707, 114-2708, 114-2882, 114-2888, 114-2893, 114-3115, 114-3256, 114-3431, 114-3508, 114-3564, 114-3646.1, 114-3896, 114-3897, 114-3901, 114-3929, 114-4090 and 114-4095 and adding and enacting new Sections 114-2893.7, 114-3288.5, 114-3317.5 and 114-3653.5 thereof, relating to traffic and vehicle regulations, as follows:

**Sec. 114-2703. Tenth Street- -Mulberry Street to Walnut Street.**

Tenth Street, on the east side, from Mulberry Street to a point 30 feet south thereof, no parking any time.

Tenth Street, on the east side, from a point 205 feet north of Mulberry Street to a point 40 feet north thereof, 24-hour loading zone.

Tenth Street, from a point 270 feet north of Mulberry Street to a point 50 feet north thereof, no parking any time.

Tenth Street, on the west side, from Walnut Street to a point 225 feet south thereof, loading zone.

Tenth Street, on the west side, from 200 feet south of Walnut Street to a point 25 feet south thereof, commercial loading zone.

**Sec. 114-2707. Tenth Street- -High Street to Woodland Avenue.**

Tenth Street, on the west side, from High Street to a point 25 feet north thereof, no parking any time.

Tenth Street, on the west side, from Woodland Avenue to a point 35 feet south thereof, no parking any time.

Tenth Street, on the east side, from High Street to a point 140 feet north thereof, no parking 4:00 p.m. to 6:00 p.m.

Tenth Street, on the east side, from a point 205 feet north of High Street to Woodland Avenue, no parking 4:00 p.m. to 6:00 p.m.

Tenth Street, on the east side, from a point 140 feet north of High Street to a point 65 feet north thereof, no parking any time.

Tenth Street, on the east side, from Woodland Avenue to a point 34 feet south thereof, no parking any time.

Tenth Street, on the east side, from a point 205 feet north of High Street to a point 25 feet north thereof, commercial loading zone.

**Sec. 114-2708. Tenth Street- -Woodland Avenue to Aurora Avenue.**

Tenth Street, on the west side, from Woodland Avenue to a point 50 feet north thereof, no parking any time.

Tenth Street, on the east side, from Woodland Avenue to a point 40 feet south of Pleasant Street, no parking 4:00 p.m. to 6:00 p.m.

Tenth Street, on the east side, from a point 113 feet south of Pleasant Street to Woodland Avenue, no parking any time.

Tenth Street, on the east side, from Pleasant Street to a point 40 feet south thereof, no parking any time.

Tenth Street, on both sides, from Pleasant Street to Methodist Drive, no parking any time.

Tenth Street, on the west side, from Keosauqua Way to Crocker Street, no parking any time.

Tenth Street, on the west side, from Day Street to Forest Avenue, no parking any time.

Tenth Street, on the east side, from a point 50 feet south of Mary Street to a point 50 feet north of Mary Street, no parking any time.

Tenth Street, on the west side, from Clark Street to College Avenue, no parking any time.

Tenth Street, on the west side, from Washington Avenue to Hickman Road, no parking any time.

Tenth Street, on the west side, from Douglas Avenue to Shawnee Avenue, no parking any time.

Tenth Street, on the east side, from Shawnee Avenue to Aurora Avenue, no parking any time.

**Sec. 114-2882. Southeast Thirty-third Street--East Court Avenue to East Payton Avenue.**

Southeast Thirty-third Street, on the east side, from East Court Avenue to Laurel Hill Road, no parking any time.

Southeast Thirty-third Street, on the west side, from Scott Avenue to a point 740 feet north thereof, no parking any time.

Southeast Thirty-third Street, on the west side, from East Southlawn Drive to the dead end south of East Hart Avenue, no parking any time.

**Sec. 114-2888. Southeast Thirty-fourth Street--East Watrous Avenue to East Payton Avenue.**

Southeast Thirty-fourth Street, on both sides, from East Watrous Avenue to Easter Lake Drive, no parking any time.

Southeast Thirty-fourth Street, on the west side, from the dead end north of East Southlawn Drive to East Payton Avenue, no parking any time.

**Sec. 114-2893. Southeast Thirty-fifth Street--East Court Avenue to East Payton Avenue.**

Southeast Thirty-fifth Street, on the west side, from Scott Avenue to a point 790 feet north thereof, no parking any time.

Southeast Thirty-fifth Street, on both sides, from Vandalia Road to a point 35 feet north thereof, no parking any time.

Southeast Thirty-fifth Street, on the east side, from Evergreen Avenue to East Emma Avenue, no parking any time.

Southeast Thirty-fifth Street, on the west side, from East Southlawn Drive to East Hart Avenue, no parking any time.

**Sec. 114-2893.7. Southeast Thirty-fifth Circle--East Hart Avenue to the dead end north of East Hart Avenue.**

Southeast Thirty-fifth Circle, on the east side, from East Hart Avenue to and including the cul-de-sac north thereof, no parking any time.

**Sec. 114-3115. East Court Avenue--First Street to East Second Street.**

East Court Avenue, on the south side, from East First Street to a point 95 feet west thereof, no parking any time.

East Court Avenue, on the north side, from East First Street to a point 65 feet west thereof, no parking any time.

East Court Avenue, on the south side, from a point 95 feet west of East First Street to a point 235 feet west thereof, reserved for city of Des Moines municipal employee permit parking, 7:00 a.m. to 4:00 p.m., Monday through Friday.

East Court Avenue, on the north side, from a point 65 feet west of East First Street to a point 240 feet west thereof, reserved for city of Des Moines municipal employee permit parking, 7:00 a.m. to 4:00 p.m., Monday through Friday.

East Court Avenue, on the south side, from East First Street to a point 50 feet west of East Second Street, reserved for official police vehicles.

East Court Avenue, on the north side, from a point 165 feet east of East First Street to a point 40 feet east thereof, loading zone.

East Court Avenue, on the south side, from East Second Street to a point 50 feet west thereof, no parking any time.

East Court Avenue, on the north side, from East First Street to a point 165 feet east thereof, no stopping or standing.

East Court Avenue, on the north side, from a point 205 feet east of East First Street to East Second Street, no stopping or standing.

East Court Avenue, on the north side, from East Second Street to a point 75 feet west thereof, no parking any time.

**Sec. 114-3256. Grand Avenue- -Thirteenth Street to Fifteenth Street.**

Grand Avenue, on the south side, from Thirteenth Street to a point 20 feet west thereof, no parking any time.

Grand Avenue, on the north side, from Thirteenth Street to a point 30 feet west thereof, no parking any time.

Grand Avenue, on the north side, from a point 30 feet west of Thirteenth Street to Fourteenth Street, no parking 4:00 p.m. to 6:00 p.m. and 10:00 p.m. to 7:00 a.m.

Grand Avenue, on the south side, from a point 20 feet west of Thirteenth Street to a point 260 feet west thereof, resident parking permit.

Grand Avenue, on the south side, from a point 280 feet west of Thirteenth Street to a point 33 feet east of Fifteenth Street, no parking 10:00 p.m. to 8:00 a.m.

Grand Avenue, on the south side, from a point 280 feet west of Thirteenth Street to a point 33 feet east of Fifteenth Street, no parking 4:00 p.m. to 6:00 p.m.

Grand Avenue, on the north side, from Fourteenth Street to a point 85 feet east of Fifteenth Street, no parking 4:00 p.m. to 6:00 p.m. and 10:00 p.m. to 7:00 a.m.

Grand Avenue, on the north side, from Fifteenth Street to a point 85 feet east thereof, no parking any time.

Grand Avenue, on the south side, from Fifteenth Street to a point 33 feet east thereof, no parking any time.

**Sec. 114-3288.5. East Hart Avenue-Indianola Avenue to East City Limits.**

East Hart Avenue, on the north side, from Southeast Thirty-third Street to Southeast Thirty-fourth Street, no parking any time.

East Hart Avenue, on the north side, from Sterling Trace to Southeast Thirty-sixth Street, no parking any time.

**Sec. 114-3317.5. East Highview Drive—East Indianola Avenue to East City Limits.**

East Highview Drive, on the north side, from Southeast Thirty-fourth Street to a point 360 feet east thereof and any part of the cul-de-sac, no parking any time.

**Sec. 114-3431. Locust Street- -Thirteenth Street to Fourteenth Street.**

Locust Street, on the north side, from Thirteenth Street to a point 20 feet west thereof, no parking any time.

Locust Street, on the south side, from Thirteenth Street to a point 70 feet west thereof, commercial loading zone.

Locust Street, on the south side, from a point 70 feet west of Thirteenth Street to Fourteenth Street, no parking any time.

Locust Street, on the north side, from a point 20 feet west of Thirteenth Street to a point 90 feet west thereof, resident parking permit parking.

Locust Street, on the north side, from a point 110 feet west of Thirteenth Street to a point 55 feet west thereof, no parking any time.

Locust Street, on the north side, from a point 165 feet west of Thirteenth Street to a point 110 feet west thereof, resident parking permit parking.

Locust Street, on the north side, from a point 275 feet west of Thirteenth Street to a point 20 feet east of Fifteenth Street, no parking 10:00 p.m. to 9:00 a.m.

Locust Street, on the south side, from a point 300 feet west of Thirteenth Street to Fifteenth Street, no parking any time.

Locust Street, on the north side, from Fifteenth Street to a point 20 feet east thereof, no parking any time.

**Sec. 114-3508. Mulberry Street- -Ninth Street to Tenth Street.**

Mulberry Street, on the north side, from Tenth Street to a point 19 feet east thereof, no parking any time.

Mulberry Street, on the north side, from Ninth Street to a point 76 feet east of Tenth Street, no parking any time.

Mulberry Street, on the south side, from Ninth Street to a point 145 feet east of Tenth Street, no parking any time.

**Sec. 114-3564. East Payton Avenue--South Union Street to East City Limits.**

East Payton Avenue, on the north side, from East Payton Avenue to East Payton Avenue, no parking any time.

East Payton Avenue, on the south side, from South Union Street to Southeast Fifth Street, no parking any time.

**Sec. 114-3646.1. East Southlawn Drive--Southeast Twenty-ninth Court to East City Limits.**

East Southlawn Drive, on the north side, Southeast Thirty-third Street to east city limits, no parking any time.

East Southlawn Drive, on the south side, from the dead end west of Southeast Thirtieth Street to and including the cul-de-sac east of Southeast Thirty-first Court, no parking any time.

**Sec. 114-3653.5. Sterling Trace--Southeast Thirty-fourth Street to Southeast Thirty-fifth Street.**

Sterling Trace, on the west side, from Southeast Thirty-fourth Street to and including the cul-de-sac north of Southeast Thirty-fifth Street, no parking any time.

**Sec. 114-3896. Tenth Street--Woodland Avenue to Pleasant Street.**

Tenth Street, on the east side, from a point 40 feet south of Pleasant Street to a point 63 feet south thereof, four-hour meters, 8:00 a.m. to 4:00 p.m.

Tenth Street, on the west side, from a point 50 feet north of Woodland Avenue to Pleasant Street, four-hour meters, 8:00 a.m. to 6:00 p.m.

**Sec. 114-3897. Tenth Street--High Street to Woodland Avenue.**

Tenth Street, on the west side, parking meter 10-601, 10-603 and 10-604 four-hour meter, 8:00 a.m. to 6:00 p.m., are designated handicapped parking spaces and are subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

Tenth Street, on the west side, from a point 25 feet north of High Street to a point 35 feet south of Woodland Avenue, four-hour meters, 8:00 a.m. to 6:00 p.m.

Tenth Street, on the east side, from High Street to a point 140 feet north thereof, four-hour meters, 8:00 a.m. to 4:00 p.m.

Tenth Street, on the east side, from a point 230 feet north of High Street to a point 34 feet south of Woodland Avenue, four-hour meters, 8:00 a.m. to 4:00 p.m.

**Sec. 114-3901. Tenth Street- -Mulberry Street to Walnut Street.**

Tenth Street, on the west side, from Mulberry Street to a point 225 feet south of Walnut Street, two-hour meters, 8:00 a.m. to 6:00 p.m.

Tenth Street, on the east side, from a point 30 feet north of Mulberry Street to a point 175 feet north thereof, four-hour meters, 8:00 a.m. to 6:00 p.m.

Tenth Street, on the east side, from a point 245 feet north of Mulberry Street to a point 25 feet north thereof, four-hour meters, 8:00 a.m. to 6:00 p.m.

**Sec. 114-3929. Mulberry Street- -Ninth Street to Tenth Street.**

Mulberry Street, on the north side, from a point 19 feet east of Tenth Street to a point 57 feet east thereof, four-hour meters, 8:00 a.m. to 6:00 p.m.

Mulberry Street, on the south side, from Tenth Street to a point 105 feet east thereof, four-hour meters, 8:00 a.m. to 6:00 p.m.

**Sec. 114-4090. East Court Avenue--Water Street to East First Street.**

East Court Avenue, on the south side, from Water Street to a point 330 feet west of East First Street, ten-hour meters, 8:00 a.m. to 6:00 p.m.

East Court Avenue, on the north side, from Water Street to a point 305 feet west of East First Street, ten-hour meters, 8:00 a.m. to 6:00 p.m.

**Sec. 114-4095. Des Moines Street--Robert D Ray Drive to East Ninth Street.**

Des Moines Street, on the south side, from a point 350 feet east of Robert D Ray Drive to a point 50 feet west of East Fourth Street, four-hour meters, 8:00 a.m. to 6:00 p.m.

Des Moines Street, on the south side, from a point 50 feet east of East Fourth Street to a point 50 feet west of East Fifth Street, ten-hour meters, 8:00 a.m. to 6:00 p.m.



Des Moines Street, on the south side, from a point 55 feet east of East fifth Street to a point 70 feet west of East Sixth Street, ten-hour meters, 8:00 a.m. to 6:00 p.m.

Des Moines Street, on the south side, from a point 60 feet east of East Sixth Street to a point 250 feet east thereof, ten-hour meters, 8:00 a.m. to 6:00 p.m.

Sec. 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
