

ORDINANCE NO. 15,169

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Sections 114-3431 and 114-4028, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Sections 114-3431 and 114-4028 relating to traffic and vehicle regulations, as follows:

**Sec. 114-3431. Locust Street--Thirteenth Street to Fifteenth Street.**

Locust Street, on the north side, from Thirteenth Street to a point 20 feet west thereof, no parking any time.

Locust Street, on the south side, from Thirteenth Street to a point 15 feet east of Fifteenth Street, no parking 7:00 a.m. to 9:00 a.m., weekdays.

Locust Street, on the south side, from Thirteenth Street to a point 70 feet west thereof, commercial loading zone, 9:00 a.m. to 6:00 p.m., Monday through Saturday.

Locust Street, on the north side, from a point 20 feet west of Thirteenth Street to a point 90 feet west thereof, resident parking permit parking.

Locust Street, on the north side, from a point 110 feet west of Thirteenth Street to a point 55 feet west thereof, no parking any time.

Locust Street, on the north side, from a point 165 feet west of Thirteenth Street to a point 140 feet west thereof, resident parking permit parking.

Locust Street, on the south side, from a point 500 feet west of Thirteenth Street to a point 50 feet west thereof, commercial loading zone, 9:00 a.m. to 6:00 p.m., Monday through Saturday.

Locust Street, on the south side, from Fifteenth Street to a point 15 feet east thereof, no parking any time.

Locust Street, on the north side, from Fifteenth Street to a point 20 feet east thereof, no parking any time.

**Sec. 114-4028. Locust Street--Thirteenth Street to Fifteenth Street.**

Locust Street, on the south side, from a point 70 feet west of Thirteenth Street to a point 500 feet west thereof, two-hour meters, 9:00 a.m. to 6:00 p.m.

Locust Street, on the south side, from a point 550 feet west of Thirteenth Street to a point 15 feet east of Fifteenth Street, four-hour meters, 9:00 a.m. to 6:00 p.m.

Locust Street, on the north side, from a point 20 feet west of Thirteenth Street to a point 20 feet east of Fifteenth Street, four-hour meters, 8:00 a.m. to 6:00 p.m.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
