

ORDINANCE NO. 15,282

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-2695, 114-2909 and 114-4013.01, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Sections 114-2695, 114-2909 and 114-4013.01, relating to traffic and vehicle regulations, as follows:

Sec. 114-2695. Ninth Street--Keosauqua Way to Aurora Avenue.

Ninth Street, on the east side, from Keosauqua Way to a point 250 feet north of Center Street, no parking any time.

Ninth Street, on the east side, from a point 75 feet south of Crocker Street to a point 100 feet north of Crocker Street, no parking any time.

Ninth Street, on the east side, from a point 250 feet north of Center Street to a point 75 feet south of Crocker Street. no parking 4:00 p.m. to 6:00 p.m.

Ninth Street, on the east side, from a point 100 feet north of Crocker Street to Day Street, no parking 4:00 p.m. to 6:00 p.m.

Ninth Street, on the east side, from a point 260 feet south of University to Enos Avenue, no parking 4:00 p.m. to 6:00 p.m.

Ninth Street, on the east side, from University Avenue to a point 260 feet south thereof, no parking any time.

Ninth Street, on the east side from University Avenue to Indiana Avenue, no parking any time. Ninth Street, on the west side, from Keosauqua Way to a point 165 feet north of Center Street, no parking any time.

Ninth Street, on the west side, from a point 165 feet north of Center Street to a point 225 feet south of Crocker Street, no parking 7:00 a.m. to 9:00 a.m.

Ninth Street, on the west side, from a point 225 feet south of Crocker Street to a point 100 feet north of Crocker Street, no parking any time.

Ninth Street, on the west side, from a point 100 feet north of Crocker Street to Day Street, no parking 7:00 a.m. to 9:00 a.m.

Ninth Street, on the east side, from School Street to a point 75 feet south thereof, no parking any time.

Ninth Street, on the east side, from Clark Street to a point 100 feet south thereof, no parking any time.

Ninth Street, on the west side, from Day Street to Hickman Road, no parking any time.

Ninth Street, on the west side, from a point 50 feet south of Euclid Avenue to a point 50 feet north of Euclid Avenue, no parking any time.

Ninth Street, on the west side, from Madison Avenue to a point 50 feet north thereof, no parking any time.

Ninth Street, on the east side, from Oak Park Avenue to Aurora Avenue, no parking any time.

Sec. 114-2909. East Thirty-ninth Court--Mattern Avenue to East Madison Avenue.

East Thirty-ninth Court, on the west side, from East Sheridan Avenue to a point 50 feet south thereof, no parking any time.

East Thirty-ninth Court, on the west side, from East Sheridan Avenue to Hull Avenue, no parking any time.

East Thirty-ninth Court, on the west side, from Easton Boulevard to a point 75 feet south thereof, no parking no time.

East Thirty-ninth Court, on the west side, from a point 75 feet south of Easton Boulevard to a point 135 feet south thereof, school passenger loading and unloading 7:00 a.m. to 4:00 p.m. school days, 30-minute limit.

East Thirty-ninth Court, on the east side, from Mattern Avenue to East Sheridan Avenue, no parking any time.

East Thirty-ninth Court, on the west side, from East Ovid Avenue to East Madison Avenue, no parking any time.

Sec. 114-4013.01. Grand Avenue--Fifteenth Street to Sixteenth Street.

Grand Avenue, on the south side, from Fifteenth Street to a point 270 feet west of Fifteenth Street, four-hour meters, 8:00 a.m. to 6:00 p.m.

Grand Avenue, on the north side, from a point 100 feet west of Fifteenth Street to a point 35 feet east of Sixteenth Street, ten-hour meters, 8:00 a.m. to 6:00 p.m.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
