

ORDINANCE NO. 15,807

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-1547.02, 114-3012, 114-3440, 114-3531 and 114-3694, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Sections 114-1547.02, 114-3012, 114-3440, 114-3531 and 114-3694, relating to traffic and vehicle regulations, as follows:

Sec. 114-1547.02. University Avenue.

University Avenue, on the south side, at a point 125 feet east of Twenty-ninth Street, school signal.

University Avenue, on the south side, at a point 90 feet west of 59th Street, pedestrian signal.

Sec. 114-3012. Bell Avenue--Southwest Ninth Street to Southwest Fourteenth Street.

Bell Avenue, on the north side, from Southwest Ninth Street to Southwest Twelfth Street, no stopping or standing.

Bell Avenue, on the south side, from Southwest Ninth Street to a point 250 feet west thereof, no parking any time.

Bell Avenue, on the south side, from a point 250 feet west of Southwest Ninth Street to a point 50 feet east of Southwest Twelfth Street, school passenger loading and unloading, 7:00 a.m. to 5:00 p.m. school days.

Bell Avenue, on the south side, from a point 50 feet east of Southwest Twelfth Street to Southwest Twelfth Street, no parking any time.

Bell Avenue, on the north side, from Southwest Twelfth Street to Heliotrope Drive, no parking any time.

Bell Avenue, on the south side, from Southwest Twelfth Street to a point 50 feet west thereof, no parking any time.

Sec. 114-3440. Loomis Avenue--South Union Street to dead end west of Heliotrope Drive.

Loomis Avenue, on the north side, from a point 130 feet east of Southwest Fourth Place to a point 460 feet east thereof, no parking any time.

Loomis Avenue, on the north side, from Southwest Ninth Street to a point 200 feet east thereof, no parking any time.

Loomis Avenue, on the south side, from South Union Street to Southwest Ninth Street, no parking any time.

Loomis Avenue, on the north side, from Southwest Ninth Street to a point 50 feet west thereof, no parking any time.

Loomis Avenue, on the north side, from a point 50 feet west of Southwest Ninth Street to a point 140 feet west thereof, school passenger loading and unloading, 7:00 a.m. to 5:00 p.m. school days.

Loomis Avenue, on the north side, from a point 190 feet west of Southwest Ninth Street to a point 90 feet west thereof is designated as handicapped parking and is subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

Loomis Avenue, on the north side, from a point 280 feet west of Southwest Ninth Street to a point 140 feet east of Southwest Twelfth Street, school passenger loading and unloading, 7:00 a.m. to 5:00 p.m. school days.

Loomis Avenue, on the north side, from a point 50 feet east of Southwest Twelfth Street to Southwest Twelfth Street, no parking any time.

Loomis Avenue, on the south side, from Southwest Ninth Street to Southwest Twelfth Street, no stopping or standing.

Loomis Avenue, on the south side, from Southwest Twelfth Street to a point 280 feet west of Heliotrope Drive, no parking any time.

Sec. 114-3531. Oak Park Avenue--Sixth Avenue to Sixteenth Street.

Oak Park Avenue, on the north side, from Sixth Avenue to a point 150 feet west thereof, two-hour parking 9:00 a.m. to 4:00 p.m.

Oak Park Avenue, on the south side, from Sixth Avenue to Eighth Street, no parking any time.

Oak Park Avenue, on the south side, from a point 265 feet west of Ninth Street to Sixteenth Street, no parking any time.

Sec. 114-3694. University Avenue--Polk Boulevard to Sixty-third Street.

University Avenue, on the south side, from Polk Boulevard to a point 165 feet west thereof, two-hour parking 9:00 a.m. to 4:00 p.m.

University Avenue, on the south side, from a point 125 feet west of Polk Boulevard to a point 25 feet west thereof, is designated as handicapped parking spaces and is subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

University Avenue, on the south side, from a point 165 feet west of Polk Boulevard to the entrance of Waveland Golf Course, no parking any time.

University Avenue, on the north side, from Polk Boulevard to Forty-eighth Street, two-hour parking 9:00 a.m. to 4:00 p.m.

University Avenue, on the north side, from Forty-eighth Street to a point 90 feet west thereof, no parking any time.

University Avenue, on the north side, from a point 90 feet west of Forty-eighth Street to a point 500 feet west thereof, no parking 4:00 p.m. to 6:00 p.m.

University Avenue, on the north side, from a point 590 feet west of Forty-eighth Street to Sixty-third Street, no parking any time.

University Avenue, on the south side, from the entrance to Waveland Golf Course to Fifty-ninth Street, no parking any time.

University Avenue, on the south side, from Fifty-Ninth Street to a point 100 feet west of Fifty-ninth Street, no parking any time.

University Avenue, on the south side, from a point 100 feet west of Fifty-ninth Street to a point 225 feet west thereof, school bus loading and unloading, 7:00 a.m. to 5:00 p.m. school days.

University Avenue, on the south side, from a point 335 feet west of Fifty-ninth Street to Sixty-third Street, no parking any time.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
