

ORDINANCE NO. 15,963

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-2655, 114-2658, 114-3268, 114-3269, 114-3270, 114-3271 and 114-3565, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-2655, 114-2658, 114-3268, 114-3269, 114-3270, 114-3271 and 114-3565, relating to traffic and vehicle regulations, as follows:

**Sec. 114-2655. East Sixth Street--East Grand Avenue to Des Moines Street.**

East Sixth Street, on the west side, from East Grand Avenue to a point 50 feet north thereof, no parking any time.

East Sixth Street, on the west side, from a point 50 feet north of East Grand Avenue to a point 115 feet north thereof, no parking 7:00 a.m. to 9:00 a.m., weekdays.

East Sixth Street, on the west side, from a point 50 feet north of East Grand Avenue to a point 60 feet north thereof, commercial loading zone, no parking 7:00 a.m. to 9:00 a.m., weekdays.

**Sec. 114-2658. Southwest Sixth Street--Cherry Street to Army Post Road.**

Southwest Sixth Street, on the east side, from Cherry Street to a point 25 feet south thereof, no parking any time.

Southwest Sixth Street, on the east side, from a point 25 feet south of Cherry Street to a point 90 feet south thereof, bus loading and unloading.

Southwest Sixth Street, on the east side, from a point 290 feet south of Cherry Street to West Martin Luther King Jr Parkway, no parking any time.

Southwest Sixth Street, on the west side, from Cherry Street to West Martin Luther King Jr Parkway, no parking any time.

Southwest Sixth Street, on the east side, from Elm Street to a point 335 feet south thereof, no parking any time.

Southwest Sixth Street, on the west side, from Market Street to Elm Street, no parking any time.

Southwest Sixth Street, on the east side, from Pleasant View Drive to a point 60 feet south thereof, no parking any time.

Southwest Sixth Street, on the west side, from Pleasant View Drive to Park Avenue, no parking any time.

Southwest Sixth Street, on the east side, from Park Avenue to a point 50 feet north thereof, no parking any time.

Southwest Sixth Street, on the east side, from Thornton Avenue to Rose Avenue, no parking any time.

Southwest Sixth Street, on the east side, from Emma Avenue to Hackley Avenue, no parking any time.

Southwest Sixth Street, on the west side, from McKinley Avenue to a point 75 feet south thereof, no parking any time.

Southwest Sixth Street, on the west side, from Leland Avenue to Army Post Road, no parking any time.

Southwest Sixth Street, on the east side, from Army Post Road to a point 50 feet north thereof, no parking any time.

**Sec. 114-3268. East Grand Avenue--Des Moines River Bridge to East Fourth Street.**

East Grand Avenue, on the north side, from the Des Moines River Bridge to Robert D Ray Drive, commercial loading zone.

East Grand Avenue, on the north side, from a point 325 feet east of Robert D Ray Drive to a point 165 feet east thereof, no parking any time.

East Grand Avenue, on the south side, from a point 45 feet east of Robert D Ray Drive to a point 35 feet east thereof, loading zone.

East Grand Avenue, on the north side, from a point 75 feet west of East Fourth Street to a point 25 feet west thereof, loading zone.

**Sec. 114-3269. East Grand Avenue--East Fourth Street to East Fifth Street.**

East Grand Avenue, on the north side, from a point 263 feet east of East Fourth Street to a point 80 feet east thereof, loading zone.

East Grand Avenue, on the south side, from a point 30 feet east of East Fourth Street to a point 205 feet east thereof, loading zone.

**Sec. 114-3270. East Grand Avenue--East Fifth Street to East Sixth Street.**

East Grand Avenue, on the north side, from a point 62 feet west of East Sixth Street to a point 41 feet east thereof, loading zone.

East Grand Avenue, on the south side, from a point 173 feet east of East Fifth Street to a point 102 feet east thereof, loading zone.

East Grand Avenue, on the north side, from a point 70 feet east of East Fifth Street to a point 35 feet east thereof, loading zone.

**Sec. 114-3271. East Grand Avenue--East Sixth Street to Pennsylvania Avenue.**

East Grand Avenue, on the south side, from a point 176 feet east of East Sixth Street to a point 144 feet east thereof, no parking any time.

East Grand Avenue, on the south side, from a point 320 feet east of East Sixth Street to a point 130 feet east thereof, loading zone.

East Grand Avenue, on the south side, from a point 450 feet east of East Sixth Street to Pennsylvania Avenue, no parking any time.

East Grand Avenue, on the north side, from a point 285 feet west of Pennsylvania Avenue to a point 50 feet west thereof, no parking any time.

**Sec. 114-3565. Pennsylvania Avenue--East Locust Street to East University Avenue.**

Pennsylvania Avenue, on the west side, from East Locust Street to East Grand Avenue, no parking any time.

Pennsylvania Avenue, on the west side, from Des Moines Street to Buchanan Street, no parking any time.

Pennsylvania Avenue, on the east side, from East Locust Street to East University Avenue, no parking any time.

Pennsylvania Avenue, on the west side, from Buchanan Street to East University Avenue, no parking 7:00 a.m. to 9:00 a.m.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
