

ORDINANCE NO. 16,221

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-2767, 114-3415, 114-3481, 114-3631, and 114-3702, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-2767, 114-3415, 114-3481, 114-3631, and 114-3702, relating to traffic and vehicle regulations, as follows:

**Sec. 114-2767. Sixteenth Street--West Martin Luther King Jr Parkway to Ingersoll Avenue.**

Sixteenth Street, on the west side, from West Martin Luther King Jr Parkway to Locust Street, no parking any time.

Sixteenth Street, on the east side from West Martin Luther King Jr Parkway to a point 100 feet north of Fifteenth Street, no parking any time.

Sixteenth Street, on the east side, from a point 25 feet north of Walnut Street to a point 15 feet south of Walnut Street, no parking any time.

Sixteenth Street, on the east side, from a point 122 feet north of Walnut Street to a point 80 feet north thereof, no parking any time.

Sixteenth Street, on the east side, from Locust Street to a point 10 feet south thereof, no parking any time.

Sixteenth Street, on the west side, from Grand Avenue to a point 30 feet north thereof, no parking any time.

Sixteenth Street, on the east side, from Grand Avenue to a point 50 feet north thereof, no parking any time.

Sixteenth Street, on the west side, from Ingersoll Avenue to a point 60 feet south thereof, no parking any time.

Sixteenth Street, on the east side, from Ingersoll Avenue to a point 75 feet south thereof, no parking any time.

**Sec. 114-3415. Linden Street—Dead end east of Twenty-eighth Street to Twenty-eighth Street.**

Linden Street, on the south side, from Twenty-eighth Street to a point 447 feet east thereof, no parking any time.

Linden Street, on the north side, from Twenty-eighth Street to a point 80 feet east thereof, no parking any time.

**Sec. 114-3481. Maury Street--Southeast Fifth Street to dead end east of Southeast Thirty-first Street.**

Maury Street, on both sides, from Southeast Sixth Street to 450 feet east of Southeast Fifteenth Court, no parking any time.

Maury Street, on both sides, from 450 feet east of Southeast Fifteenth Court to Southeast Eighteenth Street, no stopping or standing.

Maury Street, on both sides, from Southeast Eighteenth Street to Southeast Twenty-eighth Street, no parking any time.

Maury Street, on the south side, from Southeast Thirtieth Street to a point 50 feet east thereof, no parking any time.

Maury Street, on the north side, from Southeast Thirtieth Street to the dead end east of Southeast Thirty-first Street, no parking any time.

**Sec. 114-3631. Shaw Street--Southeast Fifth Street to dead end east of Southeast Twenty-fifth Court.**

Shaw Street, on the south side, from Southeast Fifth Street to Southeast Sixth Street, no parking any time.

Shaw Street, on the north side, from Southeast Fifth Street to a point 60 feet east thereof, no parking any time.

Shaw Street, on the north side, from a point 70 feet west of Southeast Sixth Street to Southeast Sixth Street, no parking any time.

Shaw Street, on the south side, from Southeast Seventh Street to Southeast Thirteenth Street, no parking any time.

Shaw Street, on the north side, from Southeast Fifteenth Street to and including the dead end east of Southeast Fifteenth Court, no parking any time.

Shaw Street, on the north side, from and including the dead end west of Southeast Twenty-third Court to Southeast Twenty-fourth Street, no parking any time.

Shaw Street, on the south side, from Southeast Twenty-fifth Street to a point 470 feet east of Southeast Twenty-fifth Court, no parking any time.

**Sec. 114-3702. Vale Street—Dead end west of Southeast Seventh Street to Southeast Twenty-sixth Court.**

Vale Street, on the north side, from and including the dead end turnaround west of Southeast Seventh Street to Southeast Tenth Street, no parking any time.

Vale Street, on the north side, from Southeast Twenty-fifth Court to Southeast Twenty-sixth Court, no parking any time.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
