### ORDINANCE NO. 16,283

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-2901, 114-2914, 114-2924, 114-2960, 114-3082, and 114-3515, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by Sections 114-2901, 114-2914, 114-2924, 114-2960, 114-3082, and 114-3515, relating to traffic and vehicle regulations, as follows:

# Sec. 114-2901. East Thirty-seventh Street--East University Avenue to Avenue Frederick M. Hubbell.

East Thirty-seventh Street, on the east side, from East University Avenue to a point 50 feet north thereof, no parking any time.

East Thirty-seventh Street, on the west side, from East University Avenue to Indianapolis Avenue, no parking any time.

East Thirty-seventh Street, on the east side, from a point 50 feet south of Garfield Avenue to a point 50 feet north of Garfield Avenue, no parking any time.

East Thirty-seventh Street, on the east side, from Dubuque Avenue to a point 50 feet north thereof, no parking any time.

# Sec. 114-2924. East Forty-second Street to East Aurora Avenue.

East Forty-second Street, on the west side, from Boyd Street to a point 100 feet south, no parking any time.

East Forty-second Street, on the west side, from East Sheridan Avenue to a point 50 feet north thereof, no parking any time.

East Forty-second Street, on the west side, from a point 50 feet north of East Sheridan Avenue to a point 740 feet north thereof, passenger loading and unloading 7:00 a.m. to 5:00 p.m. school days.

Clark Street, on the north side, from a point 50 feet east of Thirty-first Street to a point 50 feet west of Thirty-first Street, no parking any time.

Clark Street, on the both sides, from a point 60 feet east of Thirty-second Street to a point 50 feet west of Thirty-second Street, no parking any time.

Clark Street, on the north side, from a point 75 feet east of Thirty-third Street to a point 50 feet west of Thirty-third Street, no parking any time.

Clark Street, on the south side, from a point 100 feet east of Thirty-fourth Street to Beaver Avenue, no parking any time.

Clark Street, on the south side, from Merle Hay Road to a point 50 feet west thereof, no parking any time.

Clark Street, on the north side, from Merle Hay Road to Sixtieth Street, no parking any time.

Clark Street, on the south side, from a point 60 feet east of Sixtieth Street to Sixtieth Street, no parking any time.

Clark Street, on the south side, from Cummins Parkway to Sixty-third Street, no parking any time.

Clark Street, on the north side, from Sixty-third Street to a point 50 feet east thereof, no parking any time.

# Sec. 114-3515. Nash Drive--Chautauqua Parkway to Hickman Road.

Nash Drive, on the east side, from Chautauqua Parkway to a point 50 feet north thereof, no parking any time.

Nash Drive, on the west side, from Chautauqua Parkway to Hickman Road, no parking any time.

Nash Drive, on the east side, from a point 50 feet south of Stephenson Way to a point 60 feet north of Stephenson Way, no parking any time.

Nash Drive, on the east side, from Burlington Terrace to a point 50 feet south thereof, no parking any time.

Nash Drive, on the east side, from Hickman Road to a point 110 feet south thereof, no parking any time.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
