

ORDINANCE NO. 16,313

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-1315, 114-1335, 114-2588, 114-3244, 114-3267, 114-3268, 114-3288, 114-3419, 114-3485, and repealing Section 114-1281, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by Sections 114-1315, 114-1335, 114-2588, 114-3244, 114-3267, 114-3268, 114-3288, 114-3419, 114-3485, and repealing Section 114-1281, relating to traffic and vehicle regulations, as follows:

Sec. 114-1281. Repealed by Ord. No. 16,313.

Sec. 114-1315. Fleur Drive.

Fleur Drive, from Locust Street southwesterly including the north bound and south bound ramp systems to its reconnection with the north-south bound Fleur Drive, 30 miles per hour.

Fleur Drive, from West Martin Luther King Jr Parkway to Army Post Road, 35 miles per hour.

Fleur Drive, from Army Post Road to Border Street, 40 miles per hour.

Sec. 114-1335. Martin Luther King Jr Parkway.

Martin Luther King Jr Parkway, from West Martin Luther King Jr Parkway to Interstate 235, 35 miles per hour.

Martin Luther King Jr Parkway, from Interstate 235 to Hickman Road, 30 miles per hour.

Martin Luther King Jr Parkway, from Hickman Road to Euclid Avenue, 35 miles per hour.

Martin Luther King Jr Parkway, from Euclid Avenue Lynner Drive, 30 miles per hour.

Sec. 114-2588. Second Avenue--Locust Street to Grand Avenue.

Second Avenue, on the west side, from Grand Avenue to a point 165 feet south thereof, no parking any time.

Sec. 114-3244. Grand Avenue--Des Moines River to Second Avenue.

Grand Avenue, on the south side, from a point 105 feet west of the Des Moines River to a point 25 feet west thereof, loading zone.

Grand Avenue, on the south side, from a point 130 feet west of the Des Moines River to Second Avenue, no parking any time.

Grand Avenue, on the north side, from Second Avenue to a point 350 feet east thereof, no parking any time.

Sec. 114-3267. East Grand Avenue--Des Moines River to Robert D Ray Drive.

East Grand Avenue, on the north side, from Robert D Ray Drive to a point 180 feet west thereof, commercial loading zone.

East Grand Avenue, on the south side, from a point 200 feet west of Robert D Ray Drive to the west end of the Des Moines River Bridge, reserved for City of Des Moines municipal employee permit parking, 7:00 a.m. to 4:00 p.m., Monday through Friday.

Sec. 114-3268. East Grand Avenue--Robert D Ray Drive to East Fourth Street.

East Grand Avenue, on the north side, from a point 325 feet east of Robert D Ray Drive to a point 165 feet east thereof, no parking any time.

East Grand Avenue, on the south side, from a point 45 feet east of Robert D Ray Drive to a point 35 feet east thereof, loading zone.

East Grand Avenue, on the north side, from a point 75 feet west of East Fourth Street to a point 25 feet west thereof, loading zone.

Sec. 114-3288. Hart Avenue--South Union Street to Southeast Thirty-first Street.

Hart Avenue, on the south side, from South Union Street to a point 50 feet east thereof, no parking any time.

Hart Avenue, on the north side, from South Union Street to Southeast Eighth Street, no parking any time.

Hart Avenue, on the south side, from Southeast Fourth Street to a point 50 feet west thereof, no parking any time.

Hart Avenue, on the north side, from Southeast Fourteenth Street to a point 50 feet east thereof, no parking any time.

Hart Avenue, on the south side, from Southeast Fourteenth Street to the dead end east of Southeast Fourteenth Street, no parking any time.

Hart Avenue, on the south side, from Indianola Avenue to Southeast Twenty-fourth Court, no parking any time.

Hart Avenue, on the north side, from Southeast Twenty-fourth Street to a point 60 feet west thereof, no parking any time.

Hart Avenue, on the north side, from Southeast Twenty-fourth Street to a point 40 feet east thereof, no parking any time.

Hart Avenue, on the north side, from Southeast Twenty-fourth Court to the dead end east of Southeast Twenty-fifth Street, no parking any time.

Hart Avenue, on the south side, from Southeast Twenty-ninth Court to Southeast Thirty-first, no parking any time.

Hart Avenue, on the north side, from Southeast Thirty-third Street to Southeast Thirty-fourth Street, no parking any time.

Hart Avenue, on the north side, from Sterling Trace to Southeast Thirty-sixth Street, no parking any time.

Sec. 114-3419. Locust Street—Robert D Ray Drive to Second Avenue.

Locust Street, on the south side, from Robert D Ray Drive to a point 115 feet west thereof, no parking any time.

Locust Street, on the north side, from Robert D. Ray Drive to a point 90 feet west thereof, no parking any time.

Locust Street, on the north side, from a point 225 feet east of Second Avenue to a point 115 feet east thereof, loading zone.

Locust Street, on the south side, from Second Avenue to a point 85 feet east thereof, no parking any time.

Locust Street, on the north side, from a point 200 feet west of Robert D Ray Drive to a point 505 west thereof, reserved for City of Des Moines municipal employee permit parking, 7:00 a.m. to 4:00 p.m., Monday through Friday.

Sec. 114-3485. McKinley Avenue--South Union Street to Southwest Forty-second Street.

McKinley Avenue, on both sides, from South Union Street to Southwest Forty-second Street, no parking any time.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
