

ORDINANCE NO. 16,380

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Section 114-2880 and adding Section 114-3033.0002, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Section 114-2880 and adding Section 114-3033.0002, relating to traffic and vehicle regulations, as follows:

Sec. 114-2880. Thirty-third Street--Woodland Avenue to Aurora Avenue.

Thirty-third Street, on the east side, from Woodland Avenue to Center Street, no parking any time.

Thirty-third Street, on the west side, from Woodland Avenue to a point 50 feet north thereof, no parking any time.

Thirty-third Street, on the west side, from Center Street to Rollins Avenue, no parking any time.

Thirty-third Street, on the west side, from Crocker Street to Kingman Boulevard, no parking any time.

Thirty-third Street, on the west side, from Kingman Boulevard to Cottage Grove Avenue, no parking any time.

Thirty-third Street, on the east side, from Cottage Grove Avenue to a point 50 feet south thereof, no parking any time.

Thirty-third Street, on both sides, from Cottage Grove Avenue to Brattleboro Avenue, no parking any time.

Thirty-third Street, on the west side, from the dead end south of Forest Avenue to a point 185 feet north thereof, no parking any time.

Thirty-third Street, on the west side, from a point 50 feet south of Forest Avenue to a point 50 feet north of Forest Avenue, no parking any time.

Thirty-third Street, on the east side, from a point 700 feet south of Forest Avenue to Clark Street, no parking any time.

Thirty-third Street, on the west side, from Clark Street to Mondamin Avenue, no parking any time.

Thirty-third Street, on the east side, from a point 155 feet north of College Avenue to a point 25 feet north thereof, is designated as handicapped parking spaces and are subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

Thirty-third Street, on the west side, from Lincoln Avenue to Sheridan Avenue, no parking any time.

Thirty-third Street, on the east side, from Madison Avenue to Aurora Avenue, no parking any time.

Sec. 114-3033.0002. East Broadway Avenue—west city limits to east city limits.

East Broadway Avenue, on both sides, from the west city limits to the east city limits, no parking anytime.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
