ORDINANCE NO. 16,400

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-2730 and 114-3129, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-2730 and 114-3129, relating to traffic and vehicle regulations, as follows:

Sec. 114-2730. Twelfth Street--Keosauqua Way to Aurora Avenue.

Twelfth Street, on both sides, from Crocker Street to a point 25 feet north thereof, no parking any time.

Twelfth Street, on both sides, from School Street to a point 125 feet south thereof, no parking any time.

Twelfth Street, on the west side, from Day Street to Enos Avenue, no parking any time.

Twelfth Street, on both sides, from a point 50 feet south of Carpenter Avenue to a point 50 feet north of Carpenter Avenue, no parking any time.

Twelfth Street, on the west side, from Jefferson Avenue to a point 450 feet north thereof, no parking any time.

Twelfth Street, on the west side, from a point 50 feet south of Madison Avenue to a point 50 feet north of Madison Avenue, no parking any time.

Twelfth Street, on the west side, from a point 50 feet south of Euclid Avenue to Clinton Avenue, no parking any time.

Twelfth Street, on the east side, from Oak Park Avenue to Aurora Avenue, no parking any time.

Twelfth Street, on the west side, from a point 50 feet south of Shawnee Avenue to a point 50 feet north of Shawnee Avenue, no parking any time.

Sec. 114-3129. Crocker Street--Sixth Avenue to Fourteenth Street.

Crocker Street, on the south side, from Sixth Avenue to Eighth Street, no parking any time. Crocker Street, on the north side, from Sixth Avenue to Seventh Street, no parking any time.

Crocker Street, on the north side, from Seventh Street to a point 50 feet west thereof, no parking any time.

Crocker Street, on the north side, from a point 50 feet east of Eighth Street to a point 50 feet west of Eighth Street, no parking any time.

Crocker Street, on the south side, from Eighth Street to Ninth Street, no parking any time.

Crocker Street, on the north side, from a point 50 feet east of Ninth Street to a point 50 feet west of Ninth Street, no parking any time.

Crocker Street, on the south side, from Ninth Street to Twelfth Street, no parking any time. Crocker Street, on the north side, from Tenth Street to Eleventh Street, no parking any time.

Crocker Street, on the north side, from Twelfth Street to a point 50 feet east thereof, no parking any time.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
