

## ORDINANCE NO. 16,491

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended, by amending Sections 114-1469, 114-1811, 114-1853, 114-2603, 114-2774, 114-2781, 114-3206, 114-3255, 114-3256, 114-3258, 114-3259, 114-3260, 114-3261, 114-3431, and 114-3433, adding Section 114-1857.05, and repealing Sections 114-1905 and 114-1950, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended, by amending Sections 114-1469, 114-1811, 114-1853, 114-2603, 114-2774, 114-2781, 114-3206, 114-3255, 114-3256, 114-3258, 114-3259, 114-3260, 114-3261, 114-3431, and 114-3433, adding Section 114-1857.05, and repealing Sections 114-1905 and 114-1950, relating to traffic and vehicle regulations, as follows:

### **Sec. 114-1469. Locust Street.**

Locust Street and Second Avenue, traffic control signal.  
Locust Street and Third Street, traffic control signal.  
Locust Street and Fifth Avenue, traffic control signal.  
Locust Street and Sixth Avenue, traffic control signal.  
Locust Street and Seventh Street, traffic control signal.  
Locust Street and Eighth Street, traffic control signal.  
Locust Street and Ninth Street, traffic control signal.  
Locust Street and Tenth Street, traffic control signal.  
Locust Street and Twelfth Street, traffic control signal.  
Locust Street and Thirteenth Street, traffic control signal.  
Locust Street and Fifteenth Street, traffic control signal.  
Locust Street and Seventeenth Street, traffic control signal.

### **Sec. 114-1811. Grand Avenue.**

Grand Avenue, from Fifth Avenue to Fifteenth Street, westbound.

### **Sec. 114-1853. Locust Street.**

Locust Street, from Fifteenth Street to Second Avenue, eastbound.

### **Sec. 114-1857.05. Raccoon Street.**

Raccoon Street, from Southeast Sixth Street to Southeast Seventh Street, eastbound.

### **Sec. 114-1905. Repealed by Ordinance No. 16,491.**

**Sec. 114-2603. Third Street--Vine Street to Court Avenue.**

Third Street, on the west side, from Vine Street to a point 40 feet north thereof, no parking any time.

Third Street, on the west side, from a point 108 feet north of Vine Street to a point 30 feet north thereof, no parking any time.

Third Street, on the west side, from Court Avenue to a point 40 feet south thereof, no parking any time.

Third Street, on the west side, from a point 115 feet south of Court Avenue to a point 60 feet south thereof, loading zone.

Third Street, on the west side from Court Avenue to a point 115 feet south thereof, no parking 9 p.m. to 6 a.m., Friday and Saturday.

Third Street, on the east side, from Vine Street to a point 40 feet north thereof, no parking any time.

Third Street, on the east side, from Court Avenue to a point 80 feet south thereof, loading zone.

**Sec. 114-2774. Seventeenth Street--Locust Street to Ingersoll Avenue.**

Seventeenth Street, on the west side, from Locust Street to a point 95 feet north thereof, no parking any time.

Seventeenth Street, on the west side, from Grand Avenue to a point 95 feet south thereof, no parking any time.

Seventeenth Street, on the west side, from Grand Avenue to a point 145 feet south of Ingersoll Avenue, no parking any time.

Seventeenth Street, on the west side, from Ingersoll Avenue to a point 45 feet south thereof, no parking any time.

Seventeenth Street, on the east side, from Locust Street to Ingersoll Avenue, no parking any time.

**Sec. 114-2781. Eighteenth Street--Locust Street to Ingersoll Avenue.**

Eighteenth Street, on the east side, from a point 100 feet north of Grand Avenue to a point 40 feet north thereof, commercial loading zone, 8:00 a.m. to 6:00 p.m., Monday through Saturday.

**Sec. 114-3206. Forest Avenue--Twenty-third Street to Thirtieth Street.**

Forest Avenue, on the south side, from Twenty-third Street to Twenty-fourth Street, two-hour parking 9:00 a.m. to 4:00 p.m.

Forest Avenue, on the north side, from Twenty-fourth Street to Twenty-fifth Street, no parking 4:00 p.m. to 6:00 p.m., Monday through Friday.

Forest Avenue, on the north side, from Twenty-third Street to a point 60 feet west thereof, no parking any time.

Forest Avenue, on the north side, from a point 60 feet west of Twenty-third Street to a point 80 feet west thereof, no parking 4:00 p.m. to 6:00 p.m., Monday through Friday.

Forest Avenue, on the north side, from a point 130 feet west of Twenty-third Street to a point 140 feet west thereof, no parking 4:00 p.m. to 6:00 p.m., Monday through Friday.

Forest Avenue, on the north side, from a point 270 feet west of Twenty-third Street to a point 50 feet east of Twenty-fourth Street, no parking 4:00 p.m. to 6:00 p.m., Monday through Friday.

Forest Avenue, on the south side, from Twenty-third Street to a point 60 feet east of Twenty-fourth Street, no parking 7:00 a.m. to 9:00 a.m., Monday through Friday.

Forest Avenue, on the north side, from Twenty-fourth Street to Twenty-fifth Street, no parking any time.

Forest Avenue, on the north side, from Twenty-fifth Street to a point 125 feet west thereof, no parking any time.

Forest Avenue, on the north side, from a point 125 feet west of Twenty-fifth Street to a point 100 feet west thereof, loading zone.

Forest Avenue, on the north side, from a point 225 feet west of Twenty-fifth Street to Thirtieth Street, no parking any time.

Forest Avenue, on the south side, from a point 60 feet east of Twenty-fourth Street to Thirtieth Street, no parking any time.

#### **Sec. 114-3255. Grand Avenue--Twelfth Street to Thirteenth Street.**

Grand Avenue, on the south side, from a point 145 feet west of Twelfth Street to Thirteenth Street, no parking any time.

Grand Avenue, on the north side, from Twelfth Street to a point 40 feet west thereof, no parking any time.

Grand Avenue, on the north side, from a point 140 feet west of Twelfth Street to a point 70 feet west thereof, no parking any time.

Grand Avenue, on the north side, from a point 250 feet west of Twelfth Street to a point 53 feet west thereof, no parking any time.

#### **Sec. 114-3256. Grand Avenue--Thirteenth Street to Fifteenth Street.**

Grand Avenue, on the south side, from Thirteenth Street to a point 20 feet west thereof, no parking any time.

Grand Avenue, on the south side, from Fifteenth Street to a point 58 feet east thereof, no parking any time.

Grand Avenue, on the north side, from a point 40 feet west of Fourteenth Street to a point 45 feet west thereof, is designated handicapped parking and is subject to the same prohibition as is found in section 114-616(a) of this Code.

**Sec. 114-3258. Grand Avenue--Fifteenth Street to Seventeenth Street.**

Grand Avenue, on the south side, from Fifteenth Street to a point 255 west thereof, no parking any time.

Grand Avenue, on the south side, from a point 255 west of Fifteenth Street to a point 35 feet west thereof, loading zone, 20-minute limit.

Grand Avenue, on the south side, from Sixteenth Street to Seventeenth Street, no parking any time.

Grand Avenue, on the north side, from 30 feet west of Fifteenth Street to a point 70 feet west thereof, loading zone.

**Sec. 114-3259. Grand Avenue--Seventeenth Street to Eighteenth Street.**

Grand Avenue, on the south side, from Seventeenth Street to Eighteenth Street, no parking any time.

**Sec. 114-3260. Grand Avenue--Eighteenth Street to Nineteenth Street.**

Grand Avenue, on the south side from Eighteenth Street to a point 245 feet west thereof, no parking any time.

Grand Avenue, on the south side from a point 245 feet west of Eighteenth Street to Nineteenth Street, Bus Loading Zone, 20-minute limit.

Grand Avenue, on the north side, from Eighteenth Street to Nineteenth Street, no parking any time.

**Sec. 114-3261. Grand Avenue--Nineteenth Street to Twenty-eighth Street.**

Grand Avenue, on the south side, from Nineteenth Street to a point 440 feet west of Nineteenth Street, Bus Loading Zone, 20-minute limit.

Grand Avenue, on the south side from a point 440 feet west of Nineteenth Street to Twenty-eighth Street, no parking any time.

Grand Avenue, on the north side, from Nineteenth Street to Twenty-eighth Street, no parking any time.

Grand Avenue, on the north side, from a point 830 feet west of Nineteenth Street to a point 120 feet west thereof, in the paved border area parking inset only, is designated a handicapped parking area and is subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

**Sec. 114-3431. Locust Street--Thirteenth Street to Fifteenth Street.**

Locust Street, on the north side, from Thirteenth Street to a point 20 feet west thereof, no parking any time.

Locust Street, on the south side, from Thirteenth Street to a point 15 feet east of Fifteenth Street, no parking 7:00 a.m. to 9:00 a.m., weekdays.

Locust Street, on the south side, from Thirteenth Street to a point 70 feet west thereof, commercial loading zone, 9:00 a.m. to 6:00 p.m., Monday through Saturday.

Locust Street, on the north side, from a point 110 feet west of Thirteenth Street to a point 55 feet west thereof, no parking any time.

Locust Street, on the south side, from a point 500 feet west of Thirteenth Street to a point 50 feet west thereof, commercial loading zone, 9:00 a.m. to 6:00 p.m., Monday through Saturday.

**Sec. 114-3433. Locust Street--Fifteenth Street to Eighteenth Street.**

Locust Street, on the north side from Fifteenth Street to a point 130 feet west thereof, no parking any time.

Locust Street, on the north side, from a point 130 feet east of Fifteenth to a point 100 feet west thereof, commercial loading zone, 8:00 a.m. to 6:00 p.m., Monday through Saturday.

Locust Street, on the north side from Seventeenth Street to Fleur Drive, no parking any time. Locust Street, on the south side, from Fifteenth Street to Fleur Drive, no parking any time.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
