

ORDINANCE NO. 16,541

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended, by amending Sections 114-257.01, 114-2651, 114-2672, 114-2724, 114-3185, and 114-3430, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended, by amending Sections 114-257.01, 114-2651, 114-2672, 114-2724, 114-3185, and 114-3430, relating to traffic and vehicle regulations, as follows:

Sec. 114-257.01. Prohibited turn on red.

No person shall make a right or left turn with a vehicle after coming to a stop in obedience to a red signal until a green indication or flashing yellow arrow indication is shown at the following locations:

- (1) At the intersection of Hickman Road, Merle Hay Road and Merklin Way, prohibiting right turns from eastbound Hickman Road to southbound Merle Hay Road or Merklin Way and from northbound Merle Hay Road to eastbound Hickman Road or southbound Merklin Way.
- (2) At the intersection of Easton Boulevard, Avenue Frederick M. Hubbell and East Twenty-fifth Street, prohibiting right turns from eastbound Easton Boulevard to southbound East Twenty-fifth Street or westbound Avenue Frederick M. Hubbell or prohibiting right turns from southbound Frederick M. Hubbell Avenue to westbound Easton Boulevard.
- (3) At the intersection of Mulberry Street and Fifth Avenue, prohibiting right turns from eastbound Mulberry Street to southbound Fifth Avenue.
- (4) At the intersection of Court Avenue, and Water Street, prohibiting right turns from eastbound Court Avenue to southbound Water Street and from northbound Water Street to eastbound Court Avenue.
- (5) At the intersection of Grand Avenue and Thirty-first Street, prohibiting right turns from northbound Thirty-first Street to eastbound Grand Avenue and southbound Thirty-first Street to westbound Grand Avenue.
- (6) At the intersection of Grand Avenue and Fleur Drive, prohibiting right turns from eastbound Grand Avenue to southbound Fleur Drive.
- (7) At the intersection of the Eighth Street Service Road west of the viaduct at Mulberry Street, prohibiting right turns from northbound Eighth Street Service Road to eastbound Mulberry Street.
- (8) At the intersection of Eighth Street and Mulberry Street, prohibiting right turns from westbound Mulberry Street to northbound Eighth Street.
- (9) At the intersection of Eighth Street and Mulberry Street, prohibiting right turns from northbound Eighth Street to eastbound Mulberry Street.

- (10) At the intersection of East Thirty-third Street and Frederick M. Hubbell Avenue, prohibiting right turns from southbound East Thirty-third Street to westbound Frederick M. Hubbell Avenue.
- (11) At the intersection of Forty-second Street and Center Street, prohibiting right turns from southbound Forty-second Street to westbound Center Street.
- (12) At the intersection of Martin Luther King Jr Parkway and Interstate 235 Eastbound Exit Ramp, prohibiting right turns from eastbound Interstate 235 to southbound Martin Luther King Jr Parkway.
- (13) At the intersection of Grand Avenue and Ninth Street, prohibiting left turns from westbound Grand Avenue to southbound Ninth Street.
- (14) At the intersection of Hickman Road and 6th Avenue, prohibiting right turns from eastbound Hickman Road to southbound 6th Avenue.

Sec. 114-2651. Sixth Avenue--Euclid Avenue to Aurora Avenue.

Sixth Avenue, on the east side, from Euclid Avenue to a point 100 feet north thereof, no parking any time.

Sixth Avenue, on the east side, from a point 100 feet north of Euclid Avenue to a point 185 feet north thereof, two-hour parking 9:00 a.m. to 4:00 p.m.

Sixth Avenue, on the east side, from a point 285 feet north of Euclid Avenue to a point 35 feet north of Clinton Avenue, no parking any time.

Sixth Avenue, on the east side, from a point 35 feet north of Clinton Avenue to a point 40 feet north thereof, two-hour parking 9:00 a.m. to 4:00 p.m.

Sixth Avenue, on the east side, from a point 75 feet north of Clinton Avenue to a point 25 feet north thereof, commercial loading zone.

Sixth Avenue, on the east side, from a point 100 feet north of Clinton Avenue to a point 125 feet north thereof, two-hour parking 9:00 a.m. to 4:00 p.m.

Sixth Avenue, on the east side, from Douglas Avenue to a point 50 feet north thereof, no parking any time.

Sixth Avenue, on the west side, from Euclid Avenue to a point 90 feet north thereof, no parking any time.

Sixth Avenue, on the west side, from a point 90 feet north of Euclid Avenue to a point 42 feet north thereof, commercial loading zone.

Sixth Avenue, on the west side, from a point 132 feet north of Euclid Avenue to a point 50 feet south of Clinton Avenue, two-hour parking 9:00 a.m. to 4:00 p.m.

Sixth Avenue, on the west side, from a point 50 feet south of Clinton Avenue to Clinton Avenue, no parking any time.

Sixth Avenue, on the west side, from a point 50 feet north of Clinton Avenue to a point 50 feet south of Douglas Avenue, two-hour parking 9:00 a.m. to 4:00 p.m.

Sixth Avenue, on the west side, from Douglas Avenue to a point 75 feet north of Douglas Avenue, no parking any time.

Sixth Avenue, on both sides, from Madison Avenue to a point 100 feet south thereof, no stopping or standing.

Sixth Avenue, on the west side, from a point 100 feet south of Madison Avenue to a point 150 feet south thereof, passenger loading and unloading 7:00 a.m. to 5:00 p.m. school days.

Sixth Avenue, on the west side, from a point 250 feet south of Madison Avenue to a point 100 feet south thereof, bus loading and unloading 7:00 a.m. to 5:00 p.m. school days.

Sixth Avenue, on the west side, from a point 350 feet south of Madison Avenue to a point 130 feet south thereof, passenger loading and unloading 7:00 a.m. to 5:00 p.m. school days.

Sec. 114-2672. Southwest Seventh Street--Vine Street to Army Post Road.

Southwest Seventh Street, on both sides, from Vine Street to Tuttle Street, no parking any time.

Southwest Seventh Street, on both sides, from Tuttle Street to Indianola Road, no parking any time.

Southwest Seventh Street, on the east side, from Lacona Avenue to Bell Avenue, no parking any time.

Southwest Seventh Street, on the west side, from Loomis Avenue to Creston Avenue, no parking any time.

Southwest Seventh Street, on the east side, from Broad Street to Pleasant View Drive, no parking any time.

Southwest Seventh Street, on the west side, from Boulder Avenue to a point 45 feet south thereof, no parking any time.

Southwest Seventh Street, on the west side from a point 45 feet south of Boulder Avenue to a point 330 feet south thereof, school passenger loading and unloading, 7:00 a.m. to 5:00 p.m., school days.

Southwest Seventh Street, on the west side, from a point 375 feet south of Boulder Avenue to Park Avenue, no parking any time.

Southwest Seventh Street, on the east side, from Boulder Avenue to a point 50 feet south thereof, no parking any time.

Southwest Seventh Street, on the east side, from Park Avenue to Thornton Avenue, no parking any time.

Southwest Seventh Street, on the west side, from Park Avenue to a point 75 feet south thereof, no parking any time.

Southwest Seventh Street, on the west side, from Thornton Avenue to Rose Avenue, no parking any time.

Southwest Seventh Street, on the east side, from Rose Avenue to a point 75 feet north thereof, no parking any time.

Southwest Seventh Street, on the east side, from Maish Avenue to Philip Street, no parking any time.

Southwest Seventh Street, on the west side, from Kenyon Avenue to Porter Avenue, no parking any time.

Southwest Seventh Street, on the west side, from a point 295 feet north of Wall Avenue to Wall Avenue, no stopping or standing 7:00 a.m. to 5:00 p.m. school days.

Southwest Seventh Street, on the west side, from Wall Avenue to Army Post Road, no parking any time.

Southwest Seventh Street, on the east side, from Lally Street to Army Post Road, no parking any time.

Sec. 114-2724. Twelfth Street--Mulberry Street to Walnut Street.

Twelfth Street, on the east side, from Mulberry Street to a point 125 feet north thereof, no parking any time.

Twelfth Street, on the west side, from Walnut Street to a point 20 feet south thereof, no parking any time.

Twelfth Street, on the west side, from a point 105 feet south of Mulberry Street to a point 40 feet south thereof, loading zone.

Twelfth Street, on the west side, from Walnut Street to a point 28 feet north thereof, no parking any time.

Sec. 114-3185. Euclid Avenue--First Street to Sixth Avenue.

Euclid Avenue, on both sides, from First Street to Third Street, no parking any time.

Sec. 114-3430. Locust Street--Twelfth Street to Thirteenth Street.

Locust Street, on the south side, from a point 109 feet west of Twelfth Street to a point 91 feet west thereof, loading zone.

Locust Street, on the north side, from Thirteenth Street to a point 20 feet east thereof, no parking any time.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
