**Setting Date of Public Hearing on the Proposed  
Sixth Amendment to the SE Agribusiness Urban Renewal Plan**

WHEREAS, on January 26, 1998, by Roll Call No. 98-275, the City Council adopted the Urban Renewal Plan for the SE AgriBusiness Urban Renewal Project, and such Plan has been amended five times (the urban renewal plan as amended is hereinafter referred to as the "Plan"); and,

WHEREAS, the SE AgriBusiness Urban Renewal Project Area encompasses an irregularly shaped area generally located between S.E. 14th Street and the eastern City boundary, and between Dean Avenue and the Des Moines River; and,

WHEREAS, the purpose of the proposed Fifth Amendment to the Plan, attached hereto as Exhibit "A", is to: (a) designate property located at 1422 Scott Avenue for acquisition and disposition by the City to acquire for redevelopment purposes and to eliminate slum and blighted conditions on the property; and (b) update the Financial Condition Report to reflect the approved projects and update anticipated use of tax increment revenues in the future; and,

WHEREAS, the building and grounds at 1422 Scott Avenue constitute an ongoing nuisance, and a slum and blighted condition, and a threat to the public health, safety and welfare of the community; and,

WHEREAS, the Urban Design Review Board may review the proposed amendment at its regular meeting of February 18, 2014, and should be prepared to submit its report and recommendation to the City Council before the date proposed for public hearing by the City Council; and,

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:


1. A public hearing shall be held before the City Council to consider the proposed Sixth Amendment at 5:00 p.m. on March 10, 2014, in the City Council Chambers, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa.
2. The City Clerk is authorized and directed to publish notice of said public hearing in the form attached hereto as Exhibit "B". Said notice shall be published in the Des Moines Register on February 20, 2014.
3. The proposed Sixth Amendment to the Plan is hereby submitted to the Urban Design Review Board for its review and recommendation, with said written recommendation requested to be received by the City Council prior to the date of public hearing.

4. The City Manager or his designee is hereby designated as the City's representative to the consultation proceedings with the Des Moines Independent School District, Polk County and the Des Moines Area Community College. The consultation meeting shall be held at a time and location to be determined by the City Manager. The City Manager shall cause notice of the consultation meeting, a copy of the Notice of Public Hearing (Exhibit "B"), and a copy of the proposed Sixth Amendment to be mailed to each such affected taxing entity.
