 OF PROPERTY IN THE VICINITY OF 2700 OXFORD DRIVE**



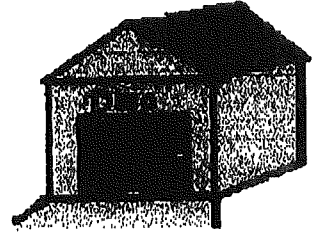
