**Setting Date of Hearing on Assignment of Commercial Operator Lease and Agreement

WHEREAS, on June 18, 2007, by Roll Call 07-1231, the Des Moines City Council approved a Commercial Operator Lease and Agreement (“Agreement”) with Mid-America Transportation Inc. dba Mid-America Jet Center (“Mid-America”); and

WHEREAS, in recent months Mid-America initiated a sale of its commercial operations at the Airport, including assignment of the Agreement; and

WHEREAS, on December 31, 2009, Mid-America was able to negotiate terms of a sale with Elliott Aviation of Des Moines, Inc. (“Elliott”), a Fixed Based Operator tenant located immediately west of Mid-America; and

WHEREAS, part of the condition of the sale is an assignment of this Agreement, which is subject to City approval according to the terms of the Agreement; and


