APPROVAL OF PRAIRIE MEADOWS 2007 COMMUNITY BETTERMENT GRANT AGREEMENT

WHEREAS, the Des Moines Park and Recreation Department is charged with the care of the grounds of the municipal cemeteries; and

WHEREAS, numerous headstones in the Woodland Municipal Cemetery are in need of repair; and

WHEREAS, the Park and Recreation Department submitted an application to Prairie Meadows or a grant to perform such repairs at Woodland Municipal cemetery; and

WHEREAS, Prairie Meadows has awarded the City of Des Moines a 2007 Community Betterment Grant in the amount of \$3,000.00 for the Park and Recreation Department's Woodland Cemetery restoration program; and

WHEREAS, Prairie Meadows has presented a grant agreement, a copy of which is on file in the City Clerk's Office, for execution prior to receipt of the grant funds; and

WHEREAS, under such grant agreement, the Park and Recreation Department will provide a written report on the use of the grant funds to Prairie Meadows; and.

WHEREAS, such grant will assist the Park and Recreation Department Cemetery staff in providing enhanced maintenance services at Woodland Municipal Cemetery.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa that the grant agreement between the City of Des Moines and Prairie Meadows, which is on file in the City Clerk's Office, is hereby approved and the Park and Recreation Director is hereby authorized and directed to sign said agreement on behalf of the City and the City Clerk is hereby directed to attest to said signature.
