WHEREAS, an Evaluation and Selection Committee has reviewed the proposals and has recommended that a contract for such services be awarded to Jester Insurance services, Inc.; and

WHEREAS, the City Manager desires to negotiate a contract with Jester Insurance Services, Inc.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, lowa that

- 1. The proposal for insurance agent/broker services for the City submitted by Jester Insurance Services, Inc. is hereby accepted and approved.
- 2. The City Manager is hereby authorized to negotiate a contract with Jester Insurance Services, Inc. in an amount not to exceed \$50,000.00 per year for an initial term of three years beginning on March 1, 2009 and automatically renewing for an additional three year term unless either party exercises it s right to terminate, subject to review and approval of the form of the contract by the Legal Department, and the City Manager is hereby authorized to execute such contract and a notice of termination, if deemed to be in the best interests of the City, and the City Clerk is hereby authorized to attest to the City Manager's signature.
