APPROVING PROPOSALS FROM VARIOUS SERVICE PROVIDERS FOR THE PROVISION OF CUSTODIAL SERVICES FOR MUNICIPAL BUILDINGS, DES MOINES METROPOLITAN WASTEWATER RECLAMATION AUTHORITY (WRA) FACILITIES, AND ONE DES MOINES MUNICIPAL HOUSING AGENCY (MHA) FACILITY (ROYAL VIEW MANOR ONLY) AND AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND EXECUTE CONTRACTS FOR SAME

WHEREAS, the Park and Recreation Department is charged with providing custodial services for municipal buildings; and

WHEREAS, the Park and Recreation Department has been requested to provide funding reduction ideas which will not impact, or have the least impact upon, the quality of services to the public; and

WHEREAS, the Park and Recreation Department has identified the outsourcing of the custodial care of municipal buildings, including WRA and MHA facilities, as a potential way to save significant funds; and

WHEREAS, on December 8, 2008 by Roll Call No. 08-2157 the City Council approved the issuance of a Request for Proposals for such custodial services; and

WHEREAS, on December 9, 2008, a Request for Proposals ("RFP") for custodial services was issued by the Procurement Division of the Finance Department; and

WHEREAS, the Procurement Agent solicited proposals by advertising and mailing RFP V09-58 to twenty (20) potential proposers with nine (9) proposals received; and

WHEREAS, an Evaluation and Selection Committee has reviewed the proposals and has recommended that contracts for such custodial services for a term of three (3) years be awarded as follows:
