RESOLUTION AUTHORIZING THE EXECUTION OF FIVE GRANT APPLICATIONS FOR FUNDING FROM THE IOWA OFFICE OF ENERGY INDEPENDENCE UNDER THE ENERGY EFFICIENCY AND CONSERVATION BLOCK GRANT PROGRAM

WHEREAS, the Iowa Office of Energy Independence ("OED") is requesting the submission of grant applications for energy efficiency and conservation projects under the Energy Efficiency and Conservation Block Grant Program ("EECBGP Program"); and,

WHEREAS, the purpose of the EECBGP Program is to assist local governments in creating and implementing strategies to reduce fossil fuel emissions in an environmentally sustainable manner; and,

WHEREAS, all applications must be submitted to the state by March 5, 2010, and must provide a minimum of one dollar local match for each dollar of the grant;

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. The Mayor is hereby authorized and directed to sign the grant applications under the EECBGP Program for the following City projects, subject to final preparation and approval of such applications by the City Manager:

The Mayor is hereby authorized and directed to sign the grant applications under the EECBGP Program for the following City/private projects, subject to final preparation and approval of such applications by the City Manager and a commitment from the private party to provide the required local match:
