

Part III. Agenda

Rule 16. Citizen Agenda Requests. Any citizen may request the right to have an item placed on the Agenda (including a request to speak) by filing such request in writing with the City Clerk prior to noon on the Wednesday preceding the Council meeting.

Part V. Citizen Participation

Rule 27. Citizen's Right to Address Council. Persons other than Council Members shall be permitted to address the Council only upon specific Agenda Items.

RE: Public Signage and Shuttle Stop

Dear Mayor Cownie and Des Moines City Council Members,

The City of Des Moines lacks a reasonable transportation option between two of it's biggest entertainment districts, the Downtown Court Avenue District and the West Glen Town Center. Taxi lines and wait times remain long and the cost to citizens is unreasonably high. Many people either don't have the means to afford a taxi service for travel between these locations or make the mistake of driving after they have consumed alcoholic beverages. We plan to open a shuttle service named "The Shuttle." The Shuttle will run between the Downtown Court Avenue District and West Glen Town Center. The Shuttle is to run Friday and Saturday nights from 9:00 p.m. until 3:00 a.m. By offering this shuttle service at an affordable price (\$5 one-way), we believe it will give citizens the ability to further explore the City of Des Moines and all it has to offer.

This service is going to be open to the public and because of this we think it is important to have our shuttle stop located on public property. We would like to petition to have our stop at one of these two locations: 3rd Avenue on the west side of the street, in front of Party Cove, or 3rd Avenue on the east side of the road in front of the Sinners and Saints establishment. We believe these locations would provide our company with good visibility to the citizens and also enable the shuttle to be easily accessible to the public. These two locations are also out of the way of traffic lights so it will not affect the flow of traffic in these highly congested areas. We are in the process of having street signs designed and will be sure they adhere to the minimum 7' height requirements.

We appreciate your consideration on this matter and we look forward to the City Council Meeting.
