APPROVAL OF AN AGREEMENT WITH EDMUNDSON ART FOUNDATION, INC., D/B/A THE DES MOINES ART CENTER AND NATIONWIDE MUTUAL INSURANCE COMPANY FOR DONATION OF SECURITY SERVICES FOR NOMADE SCULPTURE AT "WESTERN GATEWAY" PARK

WHEREAS, the Master Plan for the park bounded by 10th Street to 15th Street and Grand Avenue and Locust Street, commonly referred to as "Western Gateway" Park ("the Park"), envisioned works of art being placed in the Park; and

WHEREAS, John and Mary Pappajohn have loaned a sculpture entitled "Nomade" by the sculptor Juame Plensa ("the Artwork") to the Edmundson Art Foundation, Inc., d/b/a the Des Moines Art Center ("DMAC"), with the intention that the Artwork be placed in the Park; and

WHEREAS, on December 17, 2007, by Roll Call No. 07-2427, the City Council approved an agreement authorizing DMAC to install, display, and maintain the Artwork in the Park for a period of approximately ten months; and

WHEREAS, Nationwide desires to purchase and install, at its own expense, a surveillance camera at the Nationwide office building at 1100 Locust Street to be used to provide donated surveillance services of the Artwork and to donate to the City limited on-site patrols in the Park of the Artwork; and

WHEREAS, the Park and Recreation Department staff, DMAC and Nationwide have negotiated an agreement which authorizes Nationwide to provide such donated services, a copy of which is on file in the City Clerk's Office,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa that the above described Agreement Between the City of Des Moines and Edmundson Art Foundation, Inc. d/b/a The Des Moines Art Center, and Nationwide Mutual Insurance Company Regarding Donation of Security Services For Plesna Nomade Sculpture in "Western Gateway" Park, a copy of which is in the City Clerk's Office, be and is hereby approved and the Mayor is authorized and directed to sign said Agreement on behalf of the City and the City Clerk is authorized and directed to his signature.
