APPROVAL OF AMENDMENT TO CURRENT OPERATING AGREEMENT WITH EXPRESSJET AIRLINES INC., d/b/a/ CONTINENTAL EXPRESS EXTENDING THEIR SCHEDULED AIRLINE OPERATING AGREEMENT AND TERMINAL BUILDING LEASE AT THE DES MOINES INTERNATIONAL AIRPORT UNTIL JUNE 30, 2008

WHEREAS, the City of Des Moines owns and operates an airport known as Des Moines International Airport (hereinafter called the "Airport"), located in Des Moines, Polk County, Iowa; and

WHEREAS, on September 20, 1993, by Roll Call No. 93-3490, the Des Moines City Council approved Ordinance 12,040 assigning certain rights and responsibilities pertaining to the Airport to the Des Moines International Airport Board (hereinafter called the "Board"), including the right to enter into leases up to three years in duration and certain other agreements; and

WHEREAS, on June 12, 2001, by Resolutions A01-186-A0197, the Des Moines International Airport approved Scheduled Airline Operating Agreement and Terminal Lease or a Cargo Airline Operating Agreements (collectively "Signatory Agreements") with, among other airlines: American Airlines, Comair, Inc., Mesa Air Group d/b/a America West Express, Midwest Express Airlines, Northwest Airlines, Inc., United Air Lines, Inc., ABX Air, Inc. and United Parcel Service beginning on July 1, 2001, for aviation transportation of persons, property, and/or mail; and

WHEREAS, on July 7, 2004, by Resolutions A04-127-A135, the Des Moines International Airport Board approved amendments to certain Signatory Agreements which included the extension of the Agreements until June 30, 2006; and

WHEREAS, as other Airlines have begun operations at the Airport, the City and the other Airlines have entered into similar Signatory Agreements, which now also expire on June 30, 2006; and

WHEREAS, on May 2, 2006, by Resolution A06-84, the Des Moines International Airport Board recommended staff negotiate and present to City Council amendments extending the terms of the current Signatory Agreements until June 30, 2008; and

WHEREAS, ExpressJet Airlines Inc. has returned a Second Amendment to Scheduled Airline Operating Agreement and Terminal Building Lease extending the term of the original Signatory Agreement until June 30, 2008; and

WHEREAS, the Scheduled Airline Operating Agreement And Terminal Building Lease term with Amendment(s) will be greater that three years, which therefore requires a public hearing and City Council approval, and

WHEREAS, on February 12, 2007, by Roll Call No. 07-236, City Council directed the City Clerk to publish the notice of said proposal to set a date of public hearing for February 26, 2007; and

WHEREAS, the City Clerk published said notice on February 15, 2007; and

WHEREAS, pursuant to Sections 364.7 and 362.3 of the Code of Iowa, notice of the hearing on the proposed authorization of the Second Amendment To Scheduled Airline Operating Agreement And Terminal Building Lease between the City of Des Moines and ExpressJet Airlines Inc. has been duly published as provided by law; and

WHEREAS, the public meeting and hearing has been duly held at the time and place provided and in accordance with said notice, those interested in said Agreement with ExpressJet Airlines Inc. both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council; and

WHEREAS, the City of Des Moines has determined that such Agreement would be advantageous and beneficial to the City; and

WHEREAS, the City Council deems it advisable to act favorably and finally upon said Agreement;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

1. That upon due consideration of the facts and statements of interested persons, the objections to said proposed Second Amendment to Scheduled Airline Operating Agreement and Terminal Building Lease with ExpressJet Airlines Inc. are hereby overruled.
