RESOLUTION FIXING DATE FOR A MEETING ON THE PROPOSITION TO AUTHORIZE A LEASE AGREEMENT BETWEEN THE CITY OF DES MOINES AND E-Z-GO DIVISION OF TEXTRON INC. FOR THE RENTAL OF GOLF CARTS FOR A THREE (3) YEAR PERIOD AND ALLOWING FOR ONE THREE (3) YEAR EXTENSION THEREOF, AND FOR PROVIDING FOR PUBLICATION OF NOTICE THEREOF

WHEREAS, it is deemed necessary and advisable that the City of Des Moines, Iowa, should enter into a Lease Agreement for the rental of one-hundred and seventeen (117) golf carts to be used at the Waveland and Grandview Golf Courses by the Park and Recreation Department, said lease to be for an approximately three (3) year period and allows for one (1) three (3) year extension thereof, said lease calls for six (6) lease payments per year of \$12,365.73 each (with an annual extended price of \$74,194.38 as authorized by Sections 364.4, 364.6 and 384.83 of the Code of Iowa.; and

WHEREAS, the Lease Agreement shall be payable solely and only out of the Golf Enterprise Fund; and

WHEREAS, before the Lease Agreement may be authorized, it is necessary to comply with the provisions of the Code of Iowa, as amended, and to publish a notice of the proposal and of the time and place of the meeting at which the Council proposes to take action for the authorization of the Lease Agreement and to receive oral and/or written objections from any resident or property owner of said City to such action.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

Section 1. That this Council meet in the Council Chamber, City Hall, Des Moines, Iowa, at 5:00 o'clock P.M., on the 20th day of March, 2006, for the purpose of taking action on the matter of the authorization of a Lease Agreement between the City of Des Moines and E-Z-GO Division of Textron Inc., 9035 Kingman Drive, West Des Moines, Iowa 50266 (Colby Marriott, Sales Representative) Textron Inc., 1451 Marvin Griffin Road, Augusta, Georgia, John Garrison, President, for the rental of one-hundred and seventeen (117) golf carts to be used at the Waveland and Grandview Golf Courses, said lease to be for an approximately three (3) year period and allowing for one (1) three (3) year extension thereof, said lease calls for six (6) lease payments per year of \$12,365.73 each (with an annual

extended price of \$74,194.38), to be used by the Park and Recreation Department.

Section 2. That the Clerk is hereby directed to cause at least one publication to be made of a notice of said meeting, in a legal newspaper, printed wholly in the English language, published at least once weekly, and having general circulation in said City, said publication to be not less than four clear days nor more than twenty days before the date of said public meeting on the authorization of said Lease Agreement.

Section 3. The notice of the proposed action to authorize said Lease Agreement shall be in substantially the following form:

PUBLIC NOTICE is hereby given that the Council of the City of Des Moines, Iowa, will hold a public hearing on the 20th day of March, 2006 at 5:00 o'clock P.M., in the Council Chambers, City Hall, Des Moines, Iowa to take additional action for the authorization of a Lease Agreement between the City of Des Moines and E-Z-GO Division of Textron Inc. in the principal amount of six lease payments per year of \$12,365.73 each (resulting in total annual rental payments of \$74,194.38), to pay costs of renting of one-hundred and seventeen (117) golf carts to be used at the Waveland and Grandview Golf Courses by the Park and Recreation Department, said lease agreement contains one (1) three (3) year renewal option. The Lease Agreement will be payable from the Golf Enterprise Fund.
