PROCEDURAL RULES OF DES MOINES CITY COUNCIL:

Part III. Agenda

Rule 16. Citizen Agenda Requests. Any citizen may request the right to have an item placed on the Agenda (including a request to speak) by filing such request in writing with the City Clerk prior to noon on the Wednesday preceding the Council meeting.

Part V. Citizen Participation

Rule 27. Citizen's Right to Address Council. Persons other than Council Members shall be permitted to address the Council only upon specific Agenda Items.

Iowa Des Moines 2000 feet Housing.

Proposal draft

1. What is Iowa Des Moines 2000 feet housing?

lowa Des Moines 2000 feet Housing is a Non Profit; Males and Females, Fifty units of mainstream living based housing/treatment program and residential housing for individuals who are sex offenders on the registry and can not live in the community, or college dorms and for those who choose to live there of their own volition. In order to live there each person must agree to have a treatment counselor.

2. Benefits Iowa Des Moines 2000 feet housing:

lowa Des Moines 2000 feet Housing will provide much needed housing and assist the state in locating where the residents are housed. This includes those who are on the registry, those who fit the 2000 feet rule and those who have been deemed most likely to offend. Soon to be law, that pedophiles cannot live in dorms or those who choose to try to turn their life around and to assimilate in society. In addition, it will serve as an alternative to places similar to the Fort Des Moines programs. The main crux of the housing is to provide a place where one can be monitored and go through a comprehensive treatment program.

3. How will house operate?

The employees will consist of:

- a. The housing will based on a long term mainstream living /treatment living.
- b. The employees will be required to have who have work experience equivalent to a parole officer and group home counselor.
- c. Male and female treatment task team/counselors.

The job duties of the will consist of:

- (1). Create and implement residency requirements.
- (2). Interview each prospective tenant and be assigned clients to do "one on ones". Prepare structured treatment program, keep logs and work with the parole officer for those tenants who are finishing their parole and those who are accepted because they fit the 200 feet rule.
- 4. Two full time-live in house apartment/ medication manager.

Job duties:

- A. To assign rooms and supervise the apartment complex.
- B. To do room checks
- C. To administer medication
- D. To administer drug screens
- E. To keep a log on behavior and give written and tape log for shift change.
- F. To give report to task counselor
- 5. Four part time assistants.

Job duties. To assist as assigned:

The employee work schedule will operate with four full time live employees with shifts of seven days on and seven days off. The full time employees will have one head and assistant leader. These employees will run and supervise the part time employees and run the house as an apartment manager. The full time manager will be assisted with four part time employees on a rotation shift who will not be live-in unless one of the full time employees is on vacation or sick.

The housing mangers will also have on-site, three police officers who will work on a rotation shift. The reason for the police officers will be to provide law and order and safety for staff and Tenants.

Other employees will consist of a five member intake team which will meet with the potential tenants and decide as a team, who will live there.

Live-in rotation counselor/social workers who will meet with the intake team and put together a contractual program in order for the tenant live there. Each counselor/social worker will have one meeting with their assigned tenant. The live-in managers will:

- (a) meet with the intake team and
- (b) keep comprehensive logs of the live-in shift reports
- (c) give an annual report for the intake team
- (d) give an annual report to parole officers for those tenants who are on parole.

Two behavioral counselors will be hired to put together comprehensive group meetings. The tenants will sign with their counselor/Social worker to attend four meetings a month.

Rotation drivers will be hired to drive two company vans to take those who do not have cars for food runs, doctor appointments, and recreational outings.

The complex will have a game room and three meeting rooms. This will also provide for groups such as NA, AAA and Dual Diagnoses meeting which the tenants will be required to attend if deemed by intake time, counselor/social workers or parole officers.

Open groups will be based on the NA and AA system. The tenants will be reassured that they can talk about their illness. It is important that what is said bound strict confidentiality unless the tenants admits committing a recent crime. Open groups include anyone including volunteers. Specific groups include only those who are court-ordered.

Internships will be arranged for related job opportunities.
