## **EXECUTIVE SUMMARY**

Following recruitment, the Legal Department seeks appointment of David Ferree to fill the vacant position of Assistant City Attorney for the Intergovernmental Division. Duties of the position include legal work related to providing legal advice to the Aviation Department, and other municipal law matters.

### DISCUSSION

Upon the recent promotion of Kathleen Vanderpool, a position of Assistant City Attorney in the Infrastructure and Services Division of the Legal Department became vacant. Following a recruitment, and background review of the candidates, David Ferree was selected for the position.

Mr. Ferree graduated from the University of Iowa Law School in 1978 with high distinction. He has been employed by the State of Iowa as an Assistant Attorney General or Special Assistant Attorney General for all but three years since graduating from law school. He served as General Counsel to the Iowa Department of Transportation and the Iowa Railway Finance Authority for approximately thirteen years.
