Here are some numbers for Liar's over the last year: 75 trips to the location. 21 fight and dispute, 19 theft cases, 14 alarms, 4 Intox, 1 selling alcohol to minor, 6 Illegal parking, 10 misc. trips. From the cases made reference fights, disputes, Intox., there were 9 arrests for Intox., 3 disorderly conduct, and 1 assault. The trips seem high but if you take away the theft, alarms, Illegal parking, and misc. trips, they are not that far out of line. They also hire off duty officers.
