- 5600 Block of Welker Avenue
- E. 9th Street from Walker Street to Filmore Street
- S.W. 12th Street from Creston Avenue to Loomis Avenue
- 13th Place from Virginia Avenue to Pleasantview Drive
- Henry Avenue at Park Avenue to S.W. 12th Street at Caulder Avenue

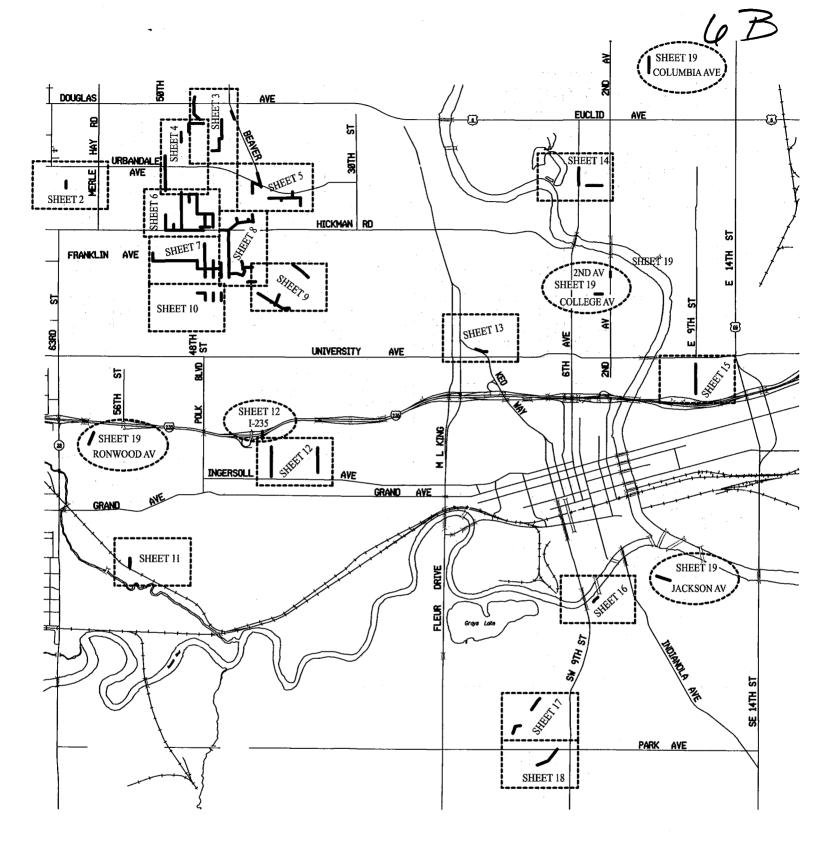
