AGENDA HEADING:

Amending Chapter 114 of the Municipal Code regarding traffic regulation changes as follows:

- A. Code Updates for Street Configuration Changes.
- B. Designated School Loading and Unloading Areas—Downtown School.
- C. Municipal Employee Permit Parking On-Street.

SYNOPSIS:

Recommend approval of first reading of the Ordinance regarding the following traffic regulation changes.

ADDITIONAL INFORMATION:

- A. The Traffic and Transportation Division has reviewed various sections of the traffic ordinances for recent street changes, particularly changes made to local streets as part of the I-235 reconstruction. Staff has identified several sections under Snow Routes, One-Way Streets, Truck Routes and Prohibited/Limited Parking that need to be revised to reflect the new street configurations. The following ordinance changes are necessary to place these revisions into effect.

- B. The Traffic and Transportation Division has worked with the Downtown School to provide designated areas around the school for parents to drop off and pick up their children. This is similar to other elementary schools throughout the City, but more complex because the same areas are designated for metered parking or commercial loading zones when not needed for school loading and unloading. Three areas have been designated for the school loading: south side of Grand Avenue from 5th to 6th; west side of 5th Avenue from Grand to Locust; and the south side of Locust Street from east of 5th to 4th Street. When the City code was modified to establish these school loading areas, the section on the south side of Grand from 5th to 6th was inadvertently omitted. In addition, there are minor changes needed for the south side of Locust from 4th to 5th to accommodate the school's early out schedule on Wednesdays. The following ordinance changes will bring the code sections into compliance with the signs that have been in place identifying the school loading locations and times.

~~Grand Avenue, on the south side, from a point 95 feet west of Fifth Avenue to a 50 feet west thereof, commercial loading zone.~~

Sec. 114-3422. Locust Street--Fourth Street to Fifth Avenue.

Locust Street, on the south side, from Fourth Street to a point 180 feet west thereof, school passenger loading and unloading, 7:00 a.m. to 9:00 a.m. and 3:00 p.m. to 6:00 p.m. Monday through Friday and ~~9:00 a.m. to 2:00 p.m.~~ to 3:00 p.m., Wednesday, 20 minutes only.

Sec. 114-3914. Grand Avenue--Fifth Avenue to Sixth Avenue.

Sec. 114-3924. Locust Street--Fourth Street to Fifth Avenue.

Locust Street, on the south side, from Fourth Street to a point 180 feet west thereof, two-hour meters, 9:00 a.m. to 3:00 p.m., Monday, Tuesday, Thursday and through Friday and 9:00 a.m. to 2:00 p.m. on Wednesday.

Sec. 114-602. Parking prohibited during certain hours on certain days.

(17) No parking 2:00 p.m. to 3:00 p.m. Wednesday.

- C. Construction of the Center Street Pedestrian Bridge will required the removal of approximately one-half of the parking spaces in the parking lot north of the Armory Building. Staff has reviewed the on-street parking in the vicinity of the Armory Building, and has determined that replacement parking could be provided along sections of East Des Moines Street and East Grand Avenue. Parking would be restricted to City employee vehicles displaying an employee parking permit between the hours of 7:00 a.m. to 4:00 p.m. Monday through Friday.

Because of the parking demand in these same areas for evening meetings at City Hall and for evening and weekend activities at the Brenton Ice Skating Rink, general public parking would be allowed after 4:00 p.m. and on weekends, on an available space basis. In addition, there is a significant amount of public parking available for Armory Building and City Hall customers along Robert D. Ray Drive and on the Grand Avenue and Locust Street bridges. This on-street employee parking is expected to be a short-term measure, until the permanent parking structure is constructed on the City Hall parking lot site.

The following ordinance changes are necessary to designate the areas for on-street City employee parking.

- (a) When official signs are erected, no person shall park a vehicle in a parking space designated as a space for City of Des Moines municipal employee permit parking unless the vehicle properly displays a municipal employee parking permit.

(b) A person who violates any provision of this section shall pay a fine of \$15.00.


