Grubb, President, 3301 106th Circle, Urbandale, IA, 50322 - as Owner, for construction of Storm Sewer Improvements described as installation of storm sewer in the new development Carman Estates Plat 5, located at East Payton Avenue and SE 24th Street, as per Plan File Nos. 444-085/089, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.


