RESOLUTION SCHEDULING HEARING ON VOLUNTARY ANNEXATION

WHEREAS, the City of Des Moines has received an Application for Voluntary Annexation from Frank and Christine Holt, seeking the voluntary annexation by the City of Des Moines of approximately 10.5 acres of land they own in the vicinity of 4250 Grandview Avenue, generally shown on Exhibit "A" and more specifically described below; NOW THEREFORE,

BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

1. The proposed annexation by the City of Des Moines of the territory shown by the map attached hereto as Exhibit "A", and as more specifically described below, shall be considered by the City Council at a public hearing to be held on May 8, 2006, at 5:00 p.m., in the Council Chambers, at which time the City Council will hear both those who oppose and those who favor the proposal.

Legal: The Northeast 1/4 of the Northwest 1/4 of the Southeast 1/4, and the East 0.5 acres of the Northwest 1/4 of the Northwest 1/4 of the Southeast 1/4 of Section 28 North, Range 79 North, Township 23 West of the 5th p.m., in Polk County, Iowa.

- 2. The City Clerk is hereby authorized and directed to publish notice of the hearing in the form attached hereto, by publication in the Des Moines Register on April 17, 2006.
- 3. The Legal Department is hereby authorized and directed to cause notice of the hearing to be mailed to all interested parties at least 14 business days prior to the hearing as required by Iowa Code §368.7.


