FEMA Disaster 1763 Project PW3526

The improvement includes dewatering sheet piling, concrete removal, reinforced concrete boat ramp, Class 'B' Revetment, Class 10 Channel Excavation, Class 10 Borrow Excavation, Granular Backfill, and Mobilization in accordance with the contract documents, including Plan Files 516-072/075 at the Harriet Street Boat Ramp, East of S.E. 14th Street at the Des Moines River, Des Moines, IA

the same to be performed in accordance with the plans and specifications which have been heretofore approved by this Council, be and the same are hereby approved, subject to receipt of the contract, bond, and certificate of insurance acceptable to the Engineering and Legal Departments. BE IT FURTHER RESOLVED: That the Mayor be and is hereby authorized and directed to execute said contract on behalf of the City of Des Moines, subject to receipt of the contract, bond, and certificate of insurance acceptable to the Engineering and Legal Departments, and the City Clerk, be and is hereby authorized and directed to attest to same. No contract shall be deemed to exist between the City of Des Moines and said Bidder until said contract has been executed by the Bidder, and shall have been approved by this Council and executed by the Mayor and attested to by the City Clerk.

BE IT FURTHER RESOLVED: That after said contract has been executed by the Mayor, the City Clerk be and is hereby authorized and directed to return the Contractor's bid security.




