in support of a motion to recommend that a 180 day moratorium be put on the approval of any site plans for vehicle display lots in the City of Des Moines until additional regulations are established to better regulate how vehicle display lots are designed and operated in the "C-2" General Retail and Highway Oriented Commercial District.

SUMMARY OF DISCUSSION

Tim Urban: Suggested a recommendation to the City Council to put a 180 day Moratorium on display lots be approved under site plans for the City of Des Moines until better regulations are established for how they should be handled in the C-2 District.

Larry Hulse: Asked what the 180 days was for.

Tim Urban: Explained it would be to not permit any approvals for display lots and during that time R&O would review it to determine what additional regulations should be made in the C-2 district to regulate display lots over and above what there are currently. Indicated it could cover additional landscaping, screening or anything else.

Bruce Heilman: Suggested enforcement is the problem and noted R&O would look at it and discuss it, but if there are any specific ideas as to why the display lots in a properly zoned C-2 District should be treated differently, R&O needs to know.

Brian Millard: Expressed concern that there is a recent site plan that was passed, but when the site opened up and it was looked at closer, it did not meet the vehicle display ordinance. Explained staff is reviewing whether the zoning ordinance can be enforced or if the car lot can continue with a vehicle display lot that is contrary to the standards.

Jim Martin: Asked if the Commission was obligated to pass zoning changes.

Larry Hulse: Explained if the Land Use Plan designates the property for commercial area for highway types of use the Land Use Plan has to be changed or it should be rezoned. Noted the Commission is not obligated to do anything but there are some other systems that dictate what they need to do. Noted the City has a lot of C-2 zoned property down major streets. Businesses change and leave, which leaves opportunity for other businesses to go in and car lots tend to be those "other businesses".

Tim Urban: Suggested if the Moratorium moves forward it will be educational for the Commission to find out how the suburbs allow or don't allow display lot uses in general. Des Moines is a "catch basin" for display lots as far as the land use is concerned and suggested it would help the City Council better understand the problem as seen from the Commission's standpoint. Called for motion.

Motion was to put a 180 day Moratorium on display lots for approval under site plans for the City of Des Moines until better regulations are established for how they should be handled in the C-2 District.

Motion passed 13-0.
