RESOLUTION APPROVING AMENDMENTS TO THE 2005-2009 U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) CONSOLIDATED PLAN

WHEREAS, the U.S. Department of Housing and Urban Development (HUD) Consolidated Plan for Affordable Housing is a five-year strategy designed to meet the needs of low and moderate-income persons while incorporating local goals and objectives to guide entitlement cities in the allocation of the Community Development Block Grant (CDBG), Home Investment Partnership Act (HOME) and Emergency Shelter Grant (ESG) federal funds; and

WHEREAS, on May 17, 2004, by Roll Call No. 04-1025, the City Council approved the Neighborhood Revitalization Board (NRB) recommended program goals for low to moderate-income residents and eligible areas of Des Moines for the 2005-2009 Des Moines Consolidated Plan for Affordable Housing; and

WHEREAS, on March 7, 2006 HUD published in the Federal Register Vol. 71, No. 44, the Notice of Outcome Performance Measurement System for Community Planning and Development Formula Grant Programs and requires all entitlement communities that prepare a Consolidated Plan to amend their current plan to adopt the Performance Measurement System as prescribed in the notice.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, to amend the 2005-2009 Consolidated Plan for Affordable Housing to adopt the Outcome Performance Measurement System for Community Planning as described in the Federal Register, Vol. 71, No. 44 (Exhibit A).

BE IT FURTHER RESOLVED that, the City Council amends the 2005-2009 Consolidated Plan to integrate the updates from the Public Housing Agency five-year and annual action plan that address the housing needs of victims of domestic violence, dating violence, sexual assault, and stalking in compliance with the Violence against Women (VAWA) and Department of Justice Reauthorization Act of 2005 (Public Law 109-162), January 5, 2006.
