CITY MANAGER RECOMMENDATION ON PROPOSED ADDITIONAL PROPERTY TAX RELIEF PLAN FOR USE OF LOCAL OPTION SALES TAX PROCEEDS

WHEREAS, by Roll Call 07-399 of February 26, 2007, the City Council of the City of Des Moines approved the Agreement for the Regional Application of Local Option Sales Taxes and creating the Tri-County Regional Authority ("28E Agreement") which 28E Agreement establishes the uses of the proceeds of the proposed one cent local option sales tax, including property tax relief, a local property tax relief plan and the allocation of a portion of the proceeds to a Tri-County Regional Authority; and

WHEREAS, by said Roll Call, the City Council established a process for public input on consideration of adoption of the City of Des Moines plan for additional local property tax relief from the discretionary portion of the local option sales tax proceeds; and

WHEREAS, in accordance with the terms of said Roll Call, the City Manager has coordinated a public process concerning the establishment of the City of Des Moines plan for additional local property tax relief which process included holding four town hall meetings and a virtual town hall meeting; and

WHEREAS, the City Manager has prepared a recommendation to the City Council for the City of Des Moines plan for additional local property tax relief from the discretionary portion of the local option sales tax proceeds which recommendation is contained in the Council Communication attached to this resolution.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the recommendation for the City of Des Moines plan for additional local property tax relief from the discretionary portion of the local option sales tax proceeds contained in Council Communication 07-158 is hereby received and filed.
