



APPROVING COMPLETION AND ACCEPTANCE OF THE PRIVATE CONSTRUCTION CONTRACT FOR STORM SEWER IMPROVEMENTS, VISTA BROADWAY INDUSTRIAL PLAT 1, BETWEEN THE UNDERGROUND COMPANY, LTD. AND VISTA REAL ESTATE CORPORATION

WHEREAS, on September 25, 2006 under Roll Call No. 06-1860, the City Council approved a private construction contract in the amount of \$66,820.00, between The Underground Company, Ltd., Duane Burkhardt, President, 12245 Dakota Street, Carlisle, IA, 50047 - as Contractor, and Vista Real Estate Corporation, Ken Smith, President, 2400 86th Street, Suite 24, Urbandale, IA, 50322 - as Owner, for construction of Storm Sewer Improvements described as Storm sewer service to Vista Broadway Industrial Plat 1, Southwest of NE 14th Street and Broadway Avenue extending from west properly line east into middle of site as per Plan File Nos. 467-075/082, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached report of the Des Moines City Engineer acknowledging the completion and recommending the acceptance of the construction of said Storm Sewer Improvements in the amount of \$66,820.00, which have been constructed in substantial compliance with the contract documents between The Underground Company, Ltd. and Vista Real Estate Corporation, which were approved under Roll Call No. 06-1860, dated September 25, 2006, be received and filed; and that completion of said Storm Sewer Improvements described as Storm sewer service to Vista Broadway Industrial Plat 1, Southwest of NE 14th Street and Broadway Avenue extending from west properly line east into middle of site as per Plan File Nos. 467-075/082, is hereby acknowledged and that said Storm Sewer Improvements are hereby accepted.


