Honorable Mayor and Members of the City Council:

Our law firm represents Baker Real Estate, L.P. ("Baker"); Andrew Holt; and Timothy Berardi ("Holt/Berardi") in reference to the proposed Third Amendment to the Planned Unit Development (PUD) commonly referred to as "Baker PUD."

On the City Council Agenda for Monday, April 6, 2009, is a public hearing regarding the Third Amendment to the Baker PUD. We would ask that this letter be received, filed, and made a part of said public hearing item, as a subparagraph.

Attached to this letter, marked as Exhibit "A," is a proposed Tax Increment Financing District, and its boundary, which includes the property in the Baker PUD, as well as other property in and/or near the Baker PUD.

The undersigned will be present at the City Council meeting of Monday, April 6, 2009, for the purpose of addressing matters for the public hearing as well as answer questions, if any, as to the proposed Tax Increment Financing (T.I.F.) District.

In the proposed Baker PUD, there is a public road proposed which is critical to the development of the proposed building (approximately 100,000 to 120,000 square feet) for the Holt/Berardi project.

Holt/Berardi and Baker have discussed with the Economic Development office of the City Manager's office the possibility of the City making an application for RISE funds for some of the costs of the proposed public road to be built in the Baker PUD.
