BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That Supplemental Agreement No. 3 to the Professional Services Agreement between the City of Des Moines and Kirkham Michael & Associates, Inc., Roger Helgoth, P.E., President, 12700 West Dodge Road, Omaha, NE, to provide construction phase services for the Southeast Connector – Des Moines River Bridge with Levee, Sanitary Sewer, and Water Main Relocation, for a cost plus fixed fee not to exceed \$757,948, a copy of which is on file in the office of the City Clerk, is hereby approved as to form and content.

BE IT FURTHER RESOLVED: That the Mayor and City Clerk are hereby authorized and directed to execute and attest, respectively, said Professional Services Agreement for and on behalf of the City of Des Moines, Iowa.

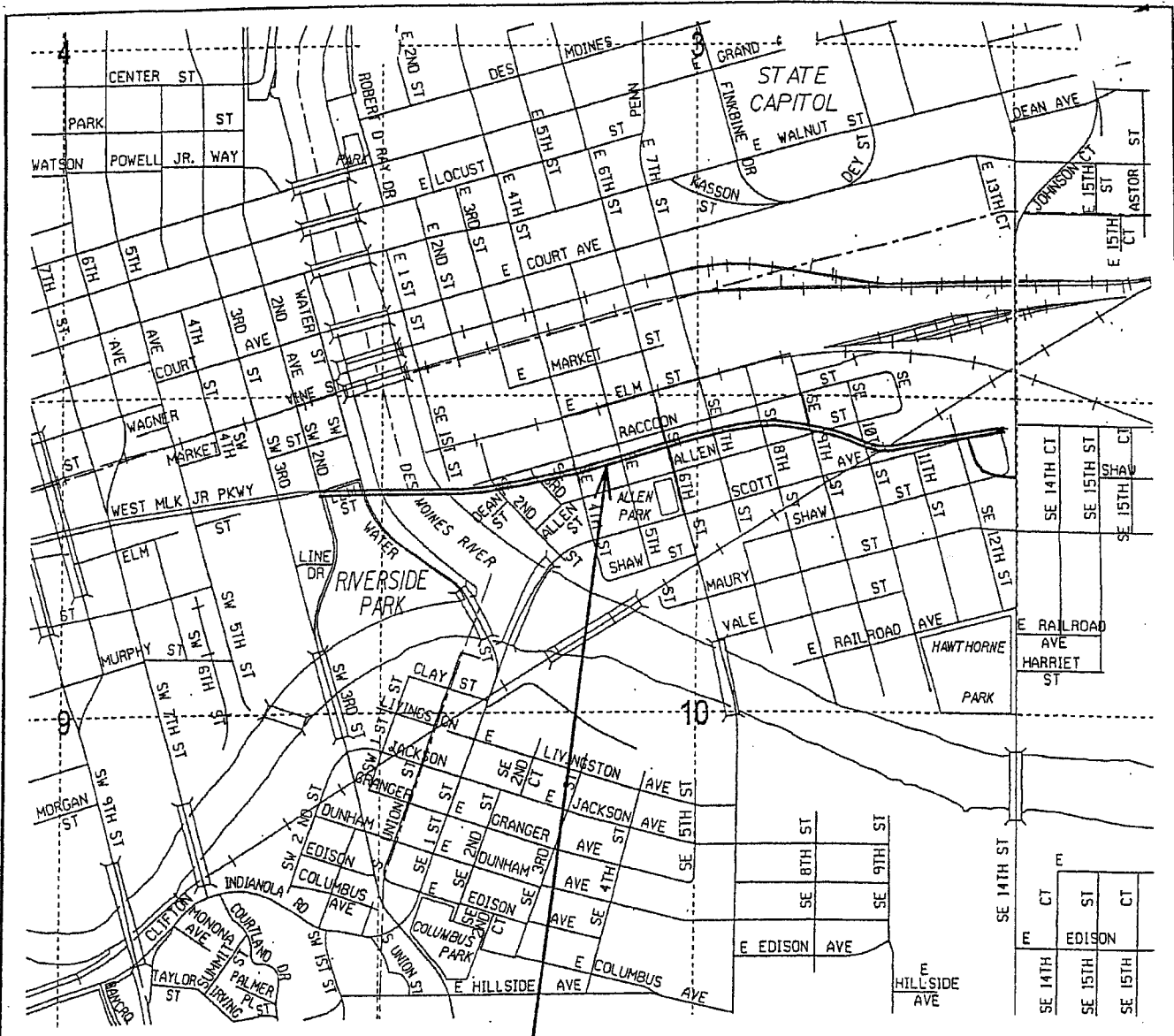

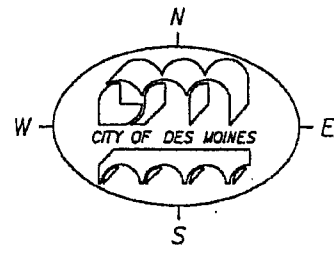
