- 2. The subdivision plat entitled Eastern Mounds Plat 1 is hereby approved, subject to receipt of satisfactory security in the amount of \$5,648 for the completion of the required public sidewalks within the plat, and subject to submission of an updated title opinion and the attachments to the plat, and approval of all such documents by the City Legal Department.
- 3. Upon satisfaction of the conditions set forth above, the Mayor and City Clerk are hereby authorized and directed to execute approval on all copies of said subdivision plat as appropriate.
