Section 1. That this Council meet in the Council Chambers, City Hall, Des Moines, Iowa, at 5:00 o'clock P.M., on the 21st day of April, 2008, for the purpose of taking action on the matter of the issuance of not to exceed \$800,000 General Obligation Bonds, the proceeds of which Bonds will be used to provide funds to pay costs of the improvement of Blank Park Zoo and community centers, the repair and renovation of swimming pools and aquatic centers, and the construction of a clubhouse facility at Grandview Golf Course, and shall bear interest at a rate not exceeding the maximum specified in the attached notice.

Section 2. That the Clerk is hereby directed to cause at least one publication to be made of a notice of said meeting in a legal newspaper, printed wholly in the English language, published at least once weekly, and having general circulation in said City, said publication to be not less than ten clear days before the date of said public meeting on the issuance of said Bonds.
